General Entry conditions

Only a fully completed "Porsche Rally Trophy Benelux Entry Form" accompanied by the respective fee, can be considered by the Trophy Organiser.

In order to meet the deadlines for the receipt of an "Application form for Entry" mentioned above, it is sufficient to send the signed application **without attachments** by e-mail to julien.frere@prospeed.be.

However, the attachments as well as the original paper version has to be submitted subsequently.

Official Vehicle Nomenclature

The official and exclusive designation of the car is "**Porsche 911 GT3 with Rally GT Kit.**" This official designation must be used exclusively by all parties (Porsche AG, the Trophy organiser, and the teams) in all communications.

The Competitor and Driver are entitled to participate only when the "Porsche Rally Trophy Benelux Entry Form" has been accepted and confirmed in writing by the Series Organiser. With this confirmation, the agreement between the Series Organiser and the competitor is concluded.

General contractual declarations by the Competitor and Driver

The Competitor and Driver declare that the statements made in the "Porsche Rally Trophy Benelux Entry Form" are correct and complete and that the Driver is in possession of a valid driver license for the car concerned and fully able to comply with the demands of competition.

They further assure that the car is in full compliance with the technical specifications of the various events and will be run only in technically and optically perfect condition in the Porsche Rally Trophy Benelux.

With their signatures they acknowledge:

- To have taken notice of the FIA International Sporting Code, including all appendices, the legal and procedural RACB rules, the PRTB 2026 Sporting & Technical Regulations, the DMSB, KNAF and RACB rally regulations, all other FIA and ASN provisions, and the participation rules.
- To consider these regulations and provisions as binding and to strictly observe them.
- That the Stewards at the respective events and the DMSB, KNAF and RACB jurisdiction, within the scope of their competencies, are entitled to fix penalties in case of infringements.
- That the regulations and provisions as well as the declaration in this "Porsche Rally Trophy Benelux Entry Form" are an integral part of the entry agreement concluded with the Trophy Organiser and the individual Rally Organisers.
- To grant the Porsche Rally Trophy Benelux and her partners the right to use any photo- or video material or to actively use the presence of a Driver and/or team during an event for marketing and promotional purposes.

The Competitor and Driver shall be held jointly and wholly responsible for any claims and responsibilities resulting from the entry. The Competitor and Driver shall accept consequences, either for or against themselves, caused by the character or behaviour of a Team member (Competitor, Driver, mechanic, assistant, guest, etc.), which relate to the agreement with the Trophy Organiser or the individual Rally Organisers, or which give reason for a damages claim or which is in conflict with the concept or spirit of the Trophy and/or harmful to its image. A possible such consequence could be exclusion from the Porsche Rally Trophy Benelux for the entrant and/or Driver(s) for a single event or the remainder of the season, without the right to get any entry fee refunded. Any such decision can be made arbitrarily by the Porsche Rally Trophy Benelux organization and cannot be appealed against.

Force majeure, labor disputes, civil disturbances, action by official bodies, and other unforeseeable, unavoidable and serious occurrences, in particular restrictions and measures due to the Covid-19 pandemic, shall release the Trophy Organiser from his duties to perform regarding the aforementioned scope of services. In case of cancellation of services, the Trophy Organiser will accordingly try to compensate the cancelled services with other services or refund a reasonable part of the entry fee to the competitor.

Non-liability declarations by the Competitor and Driver

The Competitor and Driver attend the entire event at their own risk, their connected third parties and their goods may risk damage, injury, and commercial loss including resultant loss. They bear the undivided responsibility, both civil and criminal, for any damages caused either by themselves or by the car used by them in all cases so long as no liability waiver has been agreed upon with this 'Porsche Rally Trophy Benelux entry form' document. By filling and signing the 'Porsche Rally Trophy Benelux entry form' document, the Competitor and Driver agree, within the scope of the events, to waive any claims for liabilities and/or damages of any kind against:

- Porsche AG and its representatives, sponsors and suppliers,
- The Trophy Organiser and its parent company Cup Challenge Benelux B.V. and its shareholders,
- Its representatives, sponsors, and suppliers,
- The Competitor's and Driver's own participants and helpers,
- The respective other participants, the owners and registered keepers of all cars participating in the event and respective helpers,
- FIA, RACB, KNAF, DMSB, the member organisations of the RACB, their presidents, executive bodies, managing directors and general secretaries,
- The promoter/Trophy Organiser,
- D'leteren Porsche Import, Pon Porsche Import, and their legal representatives,
- Organisers of the rally, Stewards and officials, the authorities, racing services, and all other persons involved in the organisation of the event,
- The authorities, racing services, and all other persons involved in the organisation of the events,
- The road construction authorities, in so far as damages are due to the condition of the roads and road equipment used for the event.
- the various agents, legal representatives, full-time and honorary employees of all the persons and authorities mentioned above, with the following exceptions:
- This waiver does not apply if the companies, institutions, and other organisations listed above including their legal representatives or various agents (hereinafter jointly referred to as the "beneficiaries") act grossly negligent (grob fahrlässig) or intentional (vorsätzlich) or in the event of injury to life, limb or health.
- Likewise, it does not apply in the event of a violation of material contractual obligations, namely obligations whose fulfillment makes the proper realisation of the event possible and the Competitor regularly relies on and may rely on. However, in such cases, the liability of the beneficiaries is limited to the compensation of the foreseeable, typically occurring damage.

- Likewise, it does not apply if the beneficiaries act fraudulently or assume a guarantee or a procurement risk. The waiver has also no effect on any mandatory statutory liability, including without limitation under the German Product liability act (Produkthaftungsgesetz).

This waiver shall take effect with the filing of this "Porsche Rally Trophy Benelux Entry Form". It applies to all claims for any legal reason whatsoever including claims resulting from both contractual and non-contractual liability as well as unlawful acts.

Tacit exclusions of liability shall not be affected by the aforementioned non-liability clause.

By signing the "Porsche Rally Trophy Benelux Entry Form" for the Porsche Rally Trophy Benelux 2026, the Competitor and Driver acknowledge and accept the exclusion of liability.

Upon submitting the "Porsche Rally Trophy Benelux Entry Form", the Competitor and Driver acknowledge that no insurance coverage for motor traffic (car insurance, comprehensive insurance, and motor passenger personal accident insurance) is provided for damages within a race event, aiming to achieve top speeds. The Competitor is obliged to inform the vehicle keeper and owner of the entered race cars thereof.

In case of occurring damage or determined injury respectively in the case of damages to health which may question the motor sportive fitness on a continuing basis or temporarily, the Competitor and Driver release all treating physicians – considering the resulting safety risk not only for himself/herself but also for third parties – from the medical confidentiality among each other as well as towards the Race Director, leading physician, sporting Stewards, medical director of operations, RACB/KNAF/DMSB organisation medical, coordination office automotive sports and the insurance damages office.

With their signatures, the Competitor and Driver agree to personal data being stored, transferred, and processed according to the data privacy regulations of the various ASN, under consideration of the European General Data Protection Regulation. At any time, they have the right to obtain information on these data from the ASN data protection officer and/or to practice their right of objection.

The data protection laws can be requested from the Trophy Organiser on site.

The rules of participation are defined and published by the Rally Organisers. The Trophy Organiser cannot be held responsible for Competitors or Drivers not adhering to the rules established by the Rally Organisers. The Trophy Organiser is also not responsible for any refusal by an individual Rally Organiser in allowing a Competitor or Driver to enter or participate in an event.

Insurance

With this "Application for Team Entry" the Competitor commits himself to take out sufficient insurance for himself, his racing Team and any other third party commissioned by himself against any damages relating to his participation in the Porsche Rally Trophy Benelux 2026. Neither the Rally Organiser nor the Trophy Organiser will take out any insurance of this kind. If claims for damages relating to or caused by the competitor are made against the Trophy Organiser or any third party working on behalf of the Trophy Organiser, the competitor shall release the Trophy Organiser or any

third parties working on behalf of the Trophy Organiser from any such liability claims.

Guidelines for the use of Film and Picture Material

The Trophy Organiser is the owner of all picture/live-rights of all material that is produced for PRTB for all media (internet, live-stream, social media platforms, TV, and others). The Trophy Organiser has installed several free-of-charge media databases to provide the Competitors with extensive film and picture material. The Trophy Organiser must ensure to safeguard copyright, exclusive TV rights holders, and integrity. Therefore, the consent to the use of the provided materials from the various databases is only granted while the Competitor is competing in PRTB for the purpose of showcasing the PRTB to (prospective) sponsors and Drivers and under the express reservation that the competitor must ensure at all times and without exception that no content shall

- bring the Trophy Organiser or any person and/or organisation associated therewith in to disrepute,
- be published that is considered confidential or not public,
- contain any material that is defamatory, offensive discriminatory, or blasphemous,
- violate any law or the terms of any platform on which it is placed.

If in doubt, the Competitor is obliged to contact the Trophy Organiser before using any of the material.

Consent and Waiver Declaration for the use of Film and Picture Material

1. The Competitor hereby agrees that the Trophy Organiser and the service providers commissioned by it may make movies, photos, stills, other audio and audio-visual recordings and pictures ("Recordings") or have them made of the special-stages, service park, shakedown, or any other facilities belonging to the infrastructure of the Competitor, both from within and without, within the framework of PRTB. The Competitor permits the Trophy Organiser and its service providers access to the above-mentioned facilities for this purpose. The Competitor and Driver hereby also agrees that engineers, and other team members or guests ("Team members") may be filmed within the context of making these recordings. The approval of the Competitor and Driver covers the use of the Recordings for all advertising, editorial, and/or publishing purposes of the Trophy Organiser.

2. The Trophy Organiser and its licensees, authorised representatives, partners, and legal successors are entitled based on this consent to use the recordings and the likeness, form, image, and voice of Team Members in the context of the recordings, without restriction as to location and time and in any manner whatsoever and connection with any currently available media or media available in the future and also in the form of utilisation not yet known. This covers, in particular, the use and utilisation of the recordings

- in radio and television broadcasting in any technical form irrespective of the means of transmission (terrestrial, cable, or satellite), including live streaming and IP TV
- in digital form and on online media (in particular on the Internet on the company webpage or social media channels of the Series Organiser and their licensees, authorised representatives, partners, and legal successors),

- in print media (in particular brochures, catalogs, company presentations and information, newsletters, printed works and/or compendiums),
- in the form of commercials and trailers or editorial contributions (such as in TV or radio broadcasts or the cinema), on video or audio recordings of all types (in particular CDs, DVDs, Blu-ray, USB sticks) on all other data carriers and on databases and
- in one of the aforementioned forms at festivals, trade fairs, and other events.
- Included in particular is the right to use, distribute, utilize, perform in public, broadcast, reproduce, archive, and make available for public access the Recordings.

3. The Competitor and Driver further agrees that the recordings may be modified, altered, cut, or used and utilized together with other content

Privacy statement

Cup Challenge B.V. converts and uses the personal data indicated in this document exclusively for the organisation and execution of the Porsche Rally Trophy Benelux. Personal data will not be passed on to third parties, except for series' partners and only in case such a thing is relevant for an entrant's participation in the series.

Choice of law and legal venue

This "Porsche Rally Trophy Benelux entry form", any agreement resulting from it and their interpretation are governed by the laws of Netherlands, excluding the application of the United Nations Convention on Contracts for the International Sale of Goods (CISG). The place of jurisdiction shall be Hasselt in Belgium, unless the jurisdiction of the FIA, the RACB, the KNAF, The DMSB, the Stewards, the Trophy Organiser as a judge in terms of Belgian Civil Code or their respective courts is given.

4. The Competitor and Driver guarantee that it has the rights and consents required for this consent and waiver declaration. This includes, in particular, the consent of Team members to use the recordings as described under 1. and 2. The Competitor and Driver waives the right to check and approve of the use of the recordings. The Competitor and Driver acknowledges and confirms that it is not entitled to remuneration with regard to the filming and use of the recordings.

General Contractual Declarations by the Competitor, Driver, Team Manager, car owner and other authorised representative

The Competitor, Driver, Team Manager, car owner and other authorised representative declare that by signing and submitting the "Porsche Rally Trophy Benelux Entry Form", they confirm their complete understanding and adherence to all provisions and legal notices of the Sporting and Technical Regulations of the Porsche Rally Trophy Benelux 2026 as well as of the present "Porsche Rally Trophy Benelux Entry Form". They further acknowledge they will act in full compliance with the Sporting and Technical Regulations as mentioned above.
