PROCEDURE FOR REQUESTING UNOFFICIAL TIME CHECKS

Requests for unofficial time checks must be submitted using the specific form provided on the last page of the Road Book. The form, duly signed by the Competitor, must be handed directly to the C.R.O. or, alternatively, sent via the WhatsApp application to one of the telephone numbers indicated above.

Please note that for each competition day it is permitted to request:

- during **TIME TRIALS (TT)**: a maximum of **1 time check request** and **1 request for the application of the average time due to an obstacle**;
- during **AVERAGE TRIALS (AT)**: a maximum of **1 time check request** and **1 request for the application of the average time due to an obstacle**.

Additional requests may be submitted only if they are simultaneously supported by the immediate payment of a security deposit of **€ 100,00** for each individual request.
