All Competitors / crew members

The Stewards, having received a report from the Clerk of the Course, have considered the following matter and determine the following:

- The above addressed competitor requested the allocation of a new time on SS14 where Facts the crew was slowed down at the incident scene of car No. 28
- Decision The time of competitor No. 26 on SS14 is **not** amended.
- Reason Competitor No. 26 stated that, at approximately Km 0.8 on SS14, they had lost some time slowing down at the incident scene of car No. 28.

Having examined the report from the Clerk of the Course, the information provided by the competitor, the tracking data available and the split times set by competitors No. 26 on SS14 and having reviewed the on-board video from car No. 26, the Stewards conclude that the request for a correction of the time is not justified.

Car No. 26 approached car No. 28 at Km 0.8 on SS14 and slowed down when passing through the incident scene, without stopping.

The allocation of corrected or notional times is provided for in the FIA WRC Sporting Regulations for certain cases which do, however, not specifically include a crew claiming to having been delayed in such cases that are considered as "racing incident". Furthermore, the Stewards took in consideration that this case is not supported by the same elements present in their Decision no. 4.

With a view to sporting fairness in competitions and with reference to Art. 1.1.5 of the 2024 WRC Sporting Regulations, the Stewards may consider to exercise their authority under Art. 11.9.2.a and Art. 11.9.3.j of the 2024 FIA International Sporting Code. The Stewards may thus decide that, if they deem the time loss to be significant and do not consider it as a "racing incident", a corrected time can be implemented. However, competitors must moreover be able to prove that it was extraordinary circumstances that led to any perceived time loss. The Stewards consider that the above criteria were not met in the present case.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2024 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
