Competitor: **MESTER Mircea**

Reason: **alleged breach of Art. 2 2024 Bridgestone FIA ecoRally Cup**

Time: **18:30**

Session: **leg 1**

Fact: **car is not included in the FIA list of vehicles eligible to participate on the Bridgestone FIA ecoRally Cup**

Offence: **breach of Art 2 2024 Bridgestone FIA ecoRally Cup**

Decision: **# n° 8 will not be included in the classification of the FIA eco Rally cup**

n° 8 can compete on the national competition without scoring any points for the FIA eco Rally cup.

Reason: **Article n° 2 of the Sporting Regulations of the Bridgestone FIA ecoRally Cup clearly states that, and quote: "All vehicles must be in conformity with the Technical Regulations, and be included in the list of vehicles eligible to participate (WLTP), amended by the FIA from time to time and published on the FIA website. Only vehicles compatible with the measurement system(s) proposed by the FIA will be allowed to take part in the Cup. A non-exhaustive list of compatible vehicles will be published on the FIA**


website and will be modified by the FIA in accordance with the capacity to measure consumption data.”
