The Stewards having received a report from the FIA Technical Delegate after hearing summoned and heard the driver and co-driver (SALÍKOVÁ Markéta - HOMOLOVÁ Monika) have considered the following matter, determine the following.

Competitor: **SALÍKOVÁ Markéta**

Reason: **alleged breach of Art. 3.7 of the sporting regulations of 2024 Bridgestone FIA ecoRally Cup**

Time: **11:11**

Session: **leg 2**

Fact: **overspeeding on an open traffic road**

Offence: **breach of Art 3.7 of the Sporting Regulations of 2024 Bridgestone FIA ecoRally Cup**

Decision: **350 penalty points**

Reason: **Art. 3.7 clearly states that “The event will take place on roads open to normal traffic. If some sections of the itinerary use roads closed to normal traffic, a specific mention of this will be made in the Road Book. Competitors will have to run exclusively on the roads indicated in the Road Book and must respect the traffic code regulations on pain of a penalty, which may go as far as disqualification from the event. The minimum speed in the complete itinerary is dictated by traffic laws”.**

**Safety on the road is one of the major concerns on Motorsport and even more if a competition is held on an open road. Fail to these regulations can end on a serious accident, and safety must be in competitors mind at all times.**
