5. Supplementary Regulations – Art. 19.4 – Tyres (amendment)

Category RALLYGP :

Andalucia 🛄 A

Competitors must declare during the technical inspection the make and type of rear tyre used throughout the rally.

Only this type of declared tyre may be used by the competitor.

The maximum number of rear tyres allowed is 1 per day.

Wheel and tyre of RALLYGP riders will be marked every morning.

The tyres for the entire Rally will be marked during the scrutineering at the start of the event.







6. Supplementary Regulations – Art. 19.7.3 – Reconnaissance of the qualifying stage (clarification)

Reconnaissance of Qualifying Stage is allowed under the following conditions:

- Must be done on foot, by bicycle (*including electric bicycle*) or kick scooter (including e-kick • scooter)
- There will be no limitation on the number of passages
- Schedule: (17th and) 18th of October - from 09h00 16h00 to 18h00 19h00 19th of October - from 09h00 to 12h00 11h00

7. **Supplementary Regulations – Art. 19.11.2 – Authorised assistaace** (update)

As per Art. 80.18.1 and 80.18.2 of the 2022 FIM Cross-Country Rallies World Championship regulations.

A Remote Service Area will be organized on Leg 2, where service is allowed.

Any other place of intervention (CH, DSS, ASS, CP etc.) will be prohibited

8. Supplementary Regulations – Art. 22 – Fixed Penalties – Sporting Penalties (update)

For competitors in the RallyGP, the maximum number of Sporting Penalties is 1 (one). For competitors in the Rally2, Rally3 and Quad categories, the maximum number of Sporting Penalties is 2 (two).

The value of this Sporting Penalty will be 2 (two) hours.
