The Stewards have received a report 4.1 from the chief technical scrutineer that the car of #232 Ivo Van Den Brandt entered to the FIA CEZ championship round has a different engine block than the trademark of the car's original bodywork. The Stewards have considered the following matter, determine the following:

Driver and car No: Ivo Van Den Brandt #232

Competitor: RACB

Time: 13:52

Session: Technical scrutineering

Fact: The car has a different engine block than the trademark of the car's original bodywork.

Offence: Breach of Article 10 of the 2023 Hungarian National Off-road Regulation.

Decision: The driver can take part only in the classification of the Austrian Championship.

Reason: Having considered the matter extensively, the Stewards determined that based on the Article 10 of the 2023 Hungarian National Off-road Regulation the engine block must be from a model of car of the same original registered trademark as the car's original bodywork. Therefore, the competitor is not allowed to participate in the classification of the FIA CEZ championship. However, the Stewards determined that according to the Article 4.1 of Standard Sporting Regulations Austrian Championship 2023 for Rallycross drivers that the mark of engine must not be the same as the mark of the car. Based on this the driver can take part only in the classification of the Austrian Championship.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Article 10.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
