The Stewards, having received video evidence on an incident concerning Car No. 20 on SS11 (Lota 2), summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts The Driver & Co-driver of Car No. 20 were allegedly reported for not having their

safety belt correctly fastened while the car was in motion following a wheel change on

SS11 (Lota 2).

Offence Breach of Appendix L, Chapter III, Art. 3 of the 2024 FIA International Sporting Code

and Art. 53.1 of the 2024 FIA WRC Sporting Regulations.

Decision No Further Action.

Reason The Stewards heard from the Driver OLIVER SOLBERG, the Co-Driver ELLIOTT

EDMONDSON and Team Manager OGUZHAN ILASLAN of Car No. 20 on Sunday

29th September 2024, at 18:05 hrs.

The Driver and Co-Driver explained that the Crew had finished replacing a tyre following a puncture on SS10 (Lota 2). The Crew re-entered their car and immediately started to fasten their safety belts and intercom equipment. The car was stationary for at least 20 seconds until the Crew fully fastened their safety belts. The Stewards asked the Driver if his seat belt was fastened ahead of the car's movement and he confirmed that the seat belt was fastened before the car moved. He further added that he had to pull down on his shoulder strap to tighten the harness further. The statements of the Crew were correlated with the on-board footage.


Having considered the matter extensively, the Stewards determined that there was no breach of regulations and there decide to take no further action.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2024 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
