All Competitors / crew members

The Stewards, having received a report from the FIA Deputy Technical Delegate, summoned the above competitor's representative, have considered the following matter and determine the following:

- **Facts** During pre-rally scrutineering, Competitor No. 84 requested to change the car from CITROEN DS3 R3T to PEUGEOT 208 R2, remaining in the same class RC4.
- **Decision** The Competitor is allowed to change the entered car to a PEUGEOT 208 R2 RC4 subject to passing pre-rally scrutineering.
- **Reason** A hearing was held on Thursday 5th September 2024 at 09.00 hrs in the presence of the Competitor Mr. Loizos Papageorgiou.

Mr. Papageorgiou explained that they had a problem with their CITROEN hydraulic bloc in the weeks before the rally.

They ordered a spare hydraulic bloc but, after the installation, it was not possible to fix the problem. Subsequently, they ordered another spare part directly to CITROEN, which arrived on Tuesday 3rd September 2024.

Unfortunately, also with this spare part, the problem persisted on their CITROEN DS3 car.

For these reasons, they asked for the possibility to change the car with a PEUGEOT 208 R2, remaining in the same class RC4.

As stipulated in Art. 11.9.2.a of the 2024 FIA International Sporting Code, the Stewards may settle any matter which might arise during an Event, subject to the right of appeal provided for in the Code.

Furthermore, as mentioned in Art. 11.9.1 of the 2024 FIA International Sporting Code, the Stewards shall have supreme authority for the enforcement of the Code, of the regulations of the FIA if appropriate, of national rules and Supplementary Regulations and of Official Programmes within the framework of the Event for which they are appointed.

It has also to be considered that one of the main principles of the FIA is to encourage the automobile competition as stipulated in Art. 1.1.1 of the 2024 FIA International Sporting Code.

Having considered the matter extensively, the Stewards determined that, in order to facilitate the practice of motor sports activity, granting the fairness and regularity, the change of a car, if it remains in the same class, can be allowed.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2024 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
