The Stewards, having received a report from FIA Race Director, regarding two incidents in the Final after start in the 2024 FIA World Rallycross Championship, having reviewed video evidence and hearing the drivers #1 Johan KRISTOFFERSSON and #71 Kevin HANSEN, determine the following:

**Driver and car No:** #71 Kevin HANSEN

**Competitor:** HANSEN WORLD RX TEAM

**Time (fact):** 16:45

**Fact:** Breach of Appendix L, Chapter V 2.b, FIA International Sporting Code 12.2.1 (j). and Breach of Article 22.3 of the FIA World Rallycross Championship Sporting Regulations

**Offence:** Incident in the Final after start and failure to provide footage from the Judicial Camera

**Decision:** **Disqualification from the Final**

**Reason:** After having reviewed the MVRC evidence of the incident after the start between #71 and #1 in to T1, L1 the Stewards find that #71 was wholly to blame for and made hard contact with the rear of #1. This followed contact by #1 after the start (dealt with separately under Decision No. 7).

The Stewards summoned and heard from the drivers and their team representatives, they had also requested onboard camera footage however #71 explained that this was not available. The Stewards were advised that going into the Final the team knew that the camera was not working and therefore the VBox was to be used in this instance. However, once the car had been returned to the paddock the team explained that the car was 'still hot' and for safety reasons they had needed to close down the car resulting in a loss of the video image, however an element of data was available and viewed during the hearing.

Due to the footage provided as part of this case not having sound for the Stewards the Promoter was asked to present this in a format that provided this, and this was also considered as part of the hearing.

The Stewards having taken all of the circumstance of this matter into account, and decided that the appropriate penalty is Disqualification.
