The Stewards, having received the report from the FIA Technical delegate (doc. No. 4.5 – Annex 1) and after inspecting the situation, summoned by CRO and heared the competitor/driver, issued a Decision 1, (doc. No.2.4), determined the following:

After 1stRace heat

Fact:

During the scrutineering after $\mathbf{1}^{\mathrm{st}}$ Race heat, the car was weighted after Race 1 and the car results underweight. The Race Weight (art.258-1-16.4 of the appendix J) declared by the Competitor in the PF technical sheet (FIA-PF-ID.Y5C1.350.827) is **1390** kg. The car was weighed (3 times), with the driver on board, the recorded weights are:1385 kg, 1386 kg, 1385 kg. Taking the one more in favour of the Competitor (1386 kg), it results 4 kg below the declared minimum weight.

Simulating the new performance factor (61->60), it does not change the

Offence:

Breach of Art.258-1-16.4 of the Appendix J.

Decision:

A fine of 250€ which is suspended until the end of the 2024 season, subject to do not further breach of a non-conformity with the PF technical data (outside of tolerance but without changing of group), observed during scrutineering under PF regulations (at any time after the publication of the first "starting order list"), is imposed in accordance with Article 21.1.14 EHC Sporting Regulations - Category 1. It is first time infringement during the season.

Reason:

Having considered the matter extensively, the Stewards determined that measurement has been carried out complying with the regulations and at no time during the Competition may the car measurements be out of tolerance reported in the PF Technical sheet entered in the Competition and must comply with the tolerance established by the technical regulations.







The Competitor is reminded of his right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Codeand Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
