6.3. **SPONSORS** (changes in red)

The Sponsors of the Race who are contractually entitled to do so may:

enter cars until Friday 21 February 2025 (see art. 8.3.2 of this SSR);

6.6.8 (changes in red)

In order to be selected accepted for administrative and technical checks, the entered cars must have obtained the following by the publication of the list of accepted cars: the Provisional or Definitive Certificate of the Registro 1000 Miglia. This obligation does not apply to vehicles entered for cultural and/or educational purposes.

8.3 SECURITY DEPOSIT FOR ENTRY (changes in red)

- **8.3.2.** The Competitor who submits the application for entry by taking advantage of the provisions of the sponsorship contracts referred to in art. 6.3, will be subject to the conditions of the aforementioned article:
- Friday 21 February 2025, 4:00 pm (GMT+1) will be the deadline for submitting the application; a)
- the deadline for crediting the entire amount of the security deposit to the Organizer's current account, to be made by bank transfer or credit card, will be Friday 7 March 2025.

13. CLASSIFICATIONS - COMPLAINTS - APPEALS

13.1. CLASSIFICATIONS FORESEEN

The following classifications will be drafted:

- a) GENERAL;
- **b)** BY GROUPING;
- c) SPECIALS:
 - c1) by penalties;
 - c2) for all female crews;
 - c3) for crews under 30;
 - c4) for countries with at least 10 (ten) crews starting, compiled considering the sum of the 3 best individual results taken from the general classification Italy excluded;
 - c5) for crews and cars entered by the Armed Forces;
 - c6) "Sponsors Team" compiled by adding the individual scores in the overall classification obtained by the best three (3) crews belonging to each Sponsor Team;
 - c7) "Guest Cars".
 - c8) for the crew classified first in the time trials called San Marino;
 - c9) for the crew classified first in the time trials held at the Naval Academy of Livorno;

13.3 COMPLAINTS AND APPEALS (changes in red)

The complaints and appeals must be introduced in the ways and on the terms established from the National Sports Regulation that the Competitors expressly declare to know and accept.

For each complaint the security deposit is $\in \frac{350.00}{500.00}$. For each appeal, the security deposit is $\in \frac{3,000.00}{2,000.00}$.

14. PRIZES (changes in red)

The Race will feature the following honorary prizes:

- for the first thirty (30) Crews in the general classification: prizes for both members of the Crew;
- for the first three (3) Crews in the classifications of each group: prizes for both members of the Crew;
- for the first three (3) classified Crews in the all-female Crews classification (c2 classification): prizes for both members of the Crew;
- for the first three (3) classified Crews in the under 30 classification (c3 classification) Villa Trasqua Trophy 2025: prizes for both members of the Crew;
- for the top classified nations (classification c4): 1 prize for the first, 1 prize for the second and 1 prize for the third classified nation;
- for the first classified in the other special classifications:
 - penalty classification (c1 classification) JP Morgan Trophy 2025: prizes for both members of the crew;
 - Armed Forces classification (classification c5): prizes for both members of the Crew;
 - Sponsor Team classification (classification c6): 1 single prize, for the first place;
 - Guest Car classification (classification c7): 1 single prize, for the first place.
 - "Republic of San Marino" Trophy (classification c8): for the crew classified first in the time trials called "San Marino";
 - "Navy" Trophy (classification c9): for the crew ranked first in the timed trials called "Accademia Navale di Livorno".

16. INSURANCE (changes in red)

16.1. The Organiser, as holder of a sports licence, complies with current sports regulations and, to this end, declares that it has taken out insurance in accordance with Article 56 of the RSN with Generali Assicurazioni Spa - Policy 029990361/09.05.2025.

The aforementioned Insurance Policy exclusively covers damage caused to third parties or third-party property by the Organiser or entered drivers during the Race and on the relevant route. For this purpose, "Race" means the route between two Time Controls, as identified in the Road Book or in the Bulletins. During the Race, any damage suffered by Drivers, Co-Drivers or vehicles entered for the Race will not be covered by the insurance. Damage caused to the participants themselves and to the vehicles they use is therefore excluded.

This civil liability insurance policy does not relieve Competitors and Drivers of any liability they may incur outside the scope of the insurance and additional general and special policy conditions as published on the federal website. All entered vehicles must have motor vehicle liability insurance.

16.3 **Insurance Coverage**

The maximum amount covered by the Insurance Policy is € 10.330.000,00 for each claim for damages caused to people and/or things.
