The Stewards, having received a report from the FIA Technical Delegate (Doc. No. 6.2), summoned and heard the team representative Jan CHMIELEWSKI and Monika CHMIELEWSKA (Summons No. 01), have considered the following matter, determine the following:

Fact:

During the routine re start checks of car 37 the scrutineers found that the engine block seal was missing with most of the sealing wire still in place. The Stewards received a report no 6.2 from the Technical Delegate outlining the finding of the scrutineers together with a photo of the evidence

Offence: Breach of Art. 16.3.8. and 32.2.2 of the 2025 FIA Regional Rally Sporting Regulations

Decision: 1. To impose a penalty of €500 (five hundred euro) on competitor no 37 and an additional €500 (five hundred euro) which is applied with suspension if no further breach of Art. 16.3.8. and 32.2.2 of the 2025 FIA Regional Rally Sporting Regulations is found in any competition of the 2025 European Rally Championship.

> In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: https://fiafines.fia.com. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

> 2. A new FIA seal shall be affixed by the FIA Technical Delegate as soon as practicable.

Reason:

The stewards interviewed the competitor who outlined that they had to make significant repairs to the car (mostly in the area of the Suspension) following an accident on SS1.

They said they were completely unaware of the issue of the seal until it was pointed out by the scrutineer and after investigation they were convinced that the seal had made contact with the positive part of the alternator, thus introducing a significant electric charge to the seal.

Competitors are reminded of their right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
