c) ENTRY FEES

The entry fee is:

- **320 €** (Entry fee 270 € + 50 € paddock fee – all included) when paid at the latest on 02/08/2024 (14 days before the event.)
- **375 €** (Entry fee 325 € + 50 € paddock fee – all included) when paid at the latest on 09/08/2024 (7 days before the event.)
- **540 €** (Entry fee 490 € + 50 € paddock fee – all included) when paid after 09/08/2024 (7 days before the event, but no later than three days before the administrative checks)

Remember to indicate the name of the driver during the transfer. The additional fee for a competitor who refuses to carry the organiser's sponsor's advertising is 150€

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered as a contract, the Driver, not coming to the Competition, has to apologise giving the reason as soon as possible.

d) ENTRY FEES MAY BE REFUNDED ONLY:

- to candidates who are not accepted,
- in the case of the Competition not taking place,
- if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.

d) RIGHT OF REVIEW:

- The petition of review must be made in writing and in accordance with Article 14 of the Code.
- The deposit for the petition of review is €2000.

IV. INSURANCE

As per Article 4.6 of Sporting Regulations, the sums insured should be as follows:

7.4. WRISTBANDS

The organiser provides service tickets for 5 persons of each competitor (driver + 4 persons) and a paddock ticket (car ticket), which can be received at the Welcome Centre (the Paddock gate) on arrival. The rest of the team members and supporters need to buy tickets.



7.5. PADDOCK RULES

During the race, regular cars, motorbikes, quads, electric scooters and electric bicycles are prohibited in the paddock. The Stewards can fine anyone who violates this.

Charging electric cars in the paddock area is strictly prohibited!

7.6. QUIET HOURS

In the paddock, from 00:00 o'clock till 06:00 AM, night sleep is established. During this time, it is forbidden to make noise, including running the car or any mechanical device which makes noise and disturbs night sleep. Disregarding this paragraph, the organiser has the right to penalise a driver from which the team's place is coming noise with a penalty of 500 EUR.
