The Stewards, having received reports from the Race Director heard the driver Lukas SCHWALL and competitor GSL Motorsport AMC St.Vith, have considered the following matter, determine the following:

**Driver and car No:** Lukas SCHWALL #312

**Competitor:** GSL Motorsport AMC St.Vith

**Time (fact):** 15:29

**Session:** Cross Car Final

**Facts:** Driver #312 did not respect the yellow flag and overtook car #305.

**Offence:** Breach of 2.5.5.b of the Appendix H of the FIA International Sporting Code and Art 12.2. of the FIA Sporting Regulations of the FIA European Autocross & Cross Car Championship

**Decision:** Disqualification from the Final and classified #312 last in the final and in consequence #305 will be classified in the 8<sup>th</sup> place and #321 in 9<sup>th</sup> place.

**Reason:** When the yellow flag is waived the driver is obliged to reduce the speed, not overtake and to be prepared to change direction. There is a hazard beside or partly on the track. It must be evident that a driver has reduced speed; this means a driver is expected to have braked earlier and/or noticeably reduced speed in that sector. The driver did not respect this rule. Taking this into consideration, the Stewards decided to disqualify driver #312 from the Final and classified last in the final and classified #312 last in the final and in consequence #305 will be classified in the 8<sup>th</sup> place and #321 in 9<sup>th</sup> place.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
