b) ENTRY FORMS – ENTRIES

Anybody wishing to take part in the competition must register on the FIA website, <u>www.fia.com</u>. The maximum number of starters in the event, including the support race, cannot exceed 140. **The system for booking parking places in the paddock will start on 01/05/2024 on website** www.musa.lv

c) ENTRY FEES

The entry fee is:

- 320 \in (Entry fee 270 \in + 50 \in paddock fee all included) when paid at the latest on 17/05/2024 (14 days before the event).
- 375 \in (Entry fee 325 \in + 50 \in paddock fee all included) when paid at the latest on 24/05/2024 (7 days before the event).
- 540 € (Entry fee 490 € + 50 € paddock fee all included) when paid after 24/05/2024 (7 days before the event, but no later than three days before the Administrative check).

As the entry form from the Driver and the confirmation of the acceptance from the organiser is considered a contract, the Driver, not coming to the Competition, must apologise, giving the reason as soon as possible.

d) Entry fees may be refunded only:

- to candidates who are not accepted,
- in the case of the Competition not taking place,







- if the Competitor withdraws his entry no later than the Monday before the Competition. If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, only 50% of the entry fee will be refunded.

IV. INSURANCE
