In accordance with the regulations of the FIA Central European Zone Championship ,the starting permission for abroad is not obligatory

Entry fees

CEZ, MSR,MA: 230,- €, Increased fee: 280,- €

RB: 10,- €, Increased fee : 20,-€

All the fees will be collected during the administrative checking.

Administrative checking

All drivers must report to administrative checking which will be held at Administrative building – Secretary office on 11. 07.2025 from 15:00 to 19:30. Drivers must submit all valid documents for 2025 year.

Scrutineering

Every car taking part at the event must be presented by the rider or his official representative to scrutineering which will be held on 11.07.2025 from 15:15 to 19:45

No cars will be allowed to start unless it complies with the current FIA safety regulations (Appendix J) in races of CEZ and MSR.

IV. INSURANCE

The event is registered in the SAMŠ calendar and is insured against damage caused to third parties. SAMŠ has concluded a contract with the Generali insurance company, insurance policy number: **2409816689** General liability for damage to life and health - limit 6,450,000,- General liability for property damage - limit 1,300,000,- Each rider is obliged to take out accident insurance and present the document upon request during administrative inspection.

V. NOISE CHECKING

For all vehicles, the noise limit is 100 dB.

VI. PRIZES AND CUPS

The prize giving ceremony will be organised after the Finals. Each driver of the 1st, 2nd and 3rd places must be present on the Prize giving Ceremony dressed in racing dress.

Financial prizes

Financial prizes will not be payed, drivers will be awarded prizes.

Prizes and cups

The Awards Ceremony will be organised after the Finals.

VII. ADDITIONAL INFORMATION

Running of the event

There will be two timed practice. In each training run there is a max. 8 vehicles.

Timed practice is 4 laps from the moment the vehicle crosses the finish line.

Every driver is obliged to participate in timed training. A rider who does not have a single timed lap can only start with the permission of the Decision of the Stewards.

Qualifications

There are 3 Heats of Qualifying and each will have 5 laps. (RB 4laps)

Only those competitors who have started in two races and finished at least one with the same number of laps as the winner are classified in the final races.

Semifinals and Finals

Semifinals will be: 6 laps (RB 5laps)

Finals will be: 7 laps. (RB 5laps)

Start.

At the beginning of the process, the panel with the inscription READY will be lit, within 5 seconds after the inscription goes out, it will be started, with the green light coming on.

PARC FERME - RESULTS – PROTESTS

Parc Fermé

The Parc Fermé lot will not be organized. The competitor must leave the vehicle at least 30 minutes after the publication of the preliminary final results in the depot without the intervention of mechanics.

Results

The results of each ride will be posted as soon as they will be complete. The composition of the semi -final and final rides will be posted before the start of the semifinal and final rides. The final classification is assembled according to the achieved order in the final rides. All results will be published on the official digital information board of Sportity. The riders will be informed about the approach to these results in administrative acceptance.

Protest - appeals

All the protests will be lodged in accordance with the International Sporting Code.

All the protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence to any of the stewards of the meeting, together with the financial sum.

Fire Extinguishers

Each driver is responsible for ensuring that a single piece extinguisher of minimum 5 kg is available within his own team area inside the paddock.

.Protection of the Environment

Each driver is requested to ensure that a plastic sheet (minimum 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, et.

Driver Liaison Officer

Driver Liaison Officer will be reached in driver's paddock close to entranceto the track during all the championship. The Drivers' Liaison Officer will be recognisable by yellow vest and his picture will be posted on the Official Notice Board .

DEPO

Each rider is allowed to use only one box. Only one service vehicle per competitor is allowed to enter the depot. Trailers and accompanying vehicles must be parked in a place designated for this purpose by the organizer (exception only if they fit in their designated box). When distributing the boxes, pay attention to the instructions of the authorized person of the organizer. **Reservation of boxes (see picture) is only possible via e-mail depo@autokrosmolca.sk The reservation must be included in the number of boxes, boxes, rider names and driving kits to come (delivery + trailer, bus, truck and the like).** The reservation will be evaluated, retroactively communicated, or modified according to the current occupancy and subsequently approved. **The reservation will only be valid if the competitor is registered.**

The deadline for reservations is 5.7.2025

Electricity connections will be available at the depot
The night's rest will be from 23:00 until 06:00
