The Stewards, having received a report from the Clerk of the Course, have considered the following matter and determine the following:

Facts The above addressed Competitor requested the allocation of a new time on SS8 (SOYSAMBU 1) where the crew was delayed by car No. 32 (SAMMAN SINGH VOHRA).

Decision The time of Competitor No. 29 (M-SPORT FORD WORLD RALLY TEAM) on SS8 is corrected to **24:50.8**


Reason Competitor No. 29 (M-SPORT FORD WORLD RALLY TEAM) had to stop at 21.8km on SS8 (SOYSAMBU 1) as car No. 32 (SAMMAN SINGH VOHRA) was blocking the road after the river crossing.

Having examined the report from the Clerk of the Course and the tracking data available, it is evident that the time lost by Competitor No. 29 from the stoppage of car No. 32 is approximately 45 seconds. The Stewards therefore conclude that the request for a correction of the time is justified.

The allocation of corrected or notional times is provided for in the 2023 FIA WRC Sporting Regulations for certain cases which do, however, not specifically include a crew being delayed due to the above-mentioned circumstances.

With a view to sporting fairness in competitions and with reference to Art. 1.1.5 of the 2023 FIA WRC Sporting Regulations, the Stewards exercise their authority under Art. 11.9.2.a and Art. 11.9.3.j of the 2023 FIA International Sporting Code. Considering that the time loss was significant and cannot merely be considered as a "racing incident", the Stewards decide to correct the time of Competitor No. 29 on SS8 as specified above.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2023 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
