The Stewards, having received a report from FIA Technical delegate (document No 4.3), summoned (document No 2.7) and heard the competitor/driver Ecurie 13 etoiles / Joël VOLLUZ, have considered the following matter, determine the following:

Driver and car No: 3

Competitor: Joël VOLLUZ

Time (fact): 13:10h

**Session:** After 1<sup>st</sup> practice heat.

Fact: At finish line, car No 3 is not equipped with the compulsory data logger (the car has only the connector).

Offence: Breach of:

 Art. 10.1.1 of the 2024 FIA EHC – Cat. 2 Sporting Regulations and Art. 4 – Appendix 8 – Technical Appendix to the Sporting Regulations of the 2024 FIA EHC Championship Category 2 Cars.

2024 RPM Data Logger Technical Instructions.

- Article 16.2.20 of the 2024 Appendix J- Article 258-2 Technical Regulations for Hill Climb Cars — Category 2, FIA International Sporting Code.

Decision: Disqualication from the EHC event.

**Reason:** At the end of the 1st Practice heat the car was not equipped with the mandatory data logger as required by the regulations and it was not possible to verify compliance with the maximum engine speed required (9.500 rpm, +0 tolerance).

During the hearing the driver explains that he could not find a datalogger on time to compete on the EHC Event and has already communicate to the CRO his withdrawn of the European event, asking to participate only in the national event.

The RPM data logger must be installed in strict compliance with the relevant instructions and must work at all times during the competition. It is the responsibility of each Competitor to ensure that the system is working properly therefore the Stewards decide to disqualify car number 3 from the EHC event.

The Competitor is reminded that he has the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
