4.1 Closing date for entries

4.2 Entry procedure

Non-Danish entries must submit an electronic entry application found on Sportity. The electronic entry application must be confirmed by way of personal signature by the competitor by the latest at administrative checks. A change of competitor is permitted up to the close of entries. Only the competitor entered in the event will be allowed to make this request.

An entry application will be accepted only if accompanied by the total entry fees.

Partial refund of entry fees:

The organisers may refund part of the entry fee to those competitors who for reasons of "force majeure" (duly certified by their ASN before scrutineering) were unable to start the rally.

Insurance

The entry fees include the insurance premium to insure the competitors and other parties as necessary against third party risks whilst racing on the special stages of the rally. The indemnity provided under this special insurance is DKK 20.000.000.

6. Advertising and identification

6.1 The organisers' advertising

Advertising on frontdoor plates and rally plates are reserved for the organizers' advertising. This advertising is obligatory and can't be refused by the competitors.

The obligatory advertising kept visible throughout the whole rally. Any competitor failing to comply with this will be sanctioned with a cash penalty.

The advertising will be published in an official bulletin.

6.2 Other advertisements (Optional)

An area on the outside of the front flap of the participants' cars is used for advertising space in connection with an agreement regarding television (programme sponsors). The area will be 15x60 cm measured at a distance of a maximum of 50 cm from the front edge of the front flap.

7. Reconnaissance

7.1 Number of passages

The number of passages authorised for each crew on each special stage is 2.

8. Administrative checks

8.1 Documents to be presented

- Valid entrants license
- Valid drivers and co-drivers rally competition licenses
- Driver's license
- Valid passports or ID for all foreign competitors
- ASN authorization for all foreign competitors
- Entry form completion with all details
- Road traffic insurance coverage for the rally car

9. Scrutineering

9.1 Meeting place and schedule for the inspection

See programme (Art. 3)

9.2 Noise level

Noise level control takes place in accordance with DASU Technical Regulations art. 296.

Noise levels at time of control and during the race must be in accordance with the Regulations for Rally in Denmark Art. 18.3.

9.3 Special national regulations

Technical passports of the cars are kept in the rally secretariat during the rally. Documents are returned when a signed declaration on honour is submitted. However, for discontinued participants, the car must be inspected by a scrutineer before documents can be returned.

9.4 Onboard cameras

Onboard cameras must be mounted in the car at the time of scrutineering. The onboard camera system as fitted must be approved by the scrutineers.

9.5 Tracking system

The tracking system must be mounted in the car at the time of scrutineering. The tracking system and the fitting of the tracking system must be approved by the scrutineers in accordance with Regulations for Rally in Denmark Art. 18.2.

10. Other procedures

10.1 Start parc fermé (only if applicable)

See your starting times on the Digital Notice Board when announced.

There is no starting Parc Fermé.

10.2 Starting procedure of the special stages

As starting procedure for the special stages an electronic countdown is used, so that the timing apparatus will show 5 red lights 5 seconds before the start. The red lights will turn off one by one with 1 second intervals.

The starting time is given when the last light turns off.

Jump starts are recorded by a photo cell and the 5 lights will flash.

The starting interval will be 1 minute. Starting interval might vary on round course stages.

10.3 Finish procedure

Prize giving: Will take place on the Podium ramp.

10.4 Time controls with permitted early arrival

Check-in earlier than target check-in time is allowed at TC 11A, TC 11B

10.5 Traffic code

During the rally the crews must obey the national traffic code

10.6 Service park

Location: See Art. 3.

Each registered crew is allocated a service park area of 48 m2.

Opening hours for service vehicles:

See schedule in Art. 3.

All competitors are obliged to have a liquid-proof tarpaulin under competition cars in Service Park. Failure to do so will result in a time penalty of 20 seconds.

10.7 Refuelling Area

According to Regulations for Rally in Denmark Art. 61 and subsections.

It is allowed to refuel during service. The rally car must be shut off during refuelling and a 6 kg certified fire extinguisher must be present during refuelling. The fire extinguisher must be included in the scrutineering check with the car.

Refuelling without a certified fire extinguisher will result in a time penalty of 1 minute.

10.8 Official time during the event

The official time during the event will be in accordance to http://www.timeanddate.com/worldclock/city.html?n=69

10.10 Power Stage

SS 5 (Bjerre 2) is the power stage.

10.11 Rally Safe procedure

Every participant must report back to Race control via the Rally Safe system when stopping on a stage.

Any participant who receives an overtake message via the Rally Safe system must give way as soon as possible.

10.12 Declaration on honour

A declaration on honour must be completed and signed. Failure to do so can be penalized up to exclusion at the Stewards' discretion.

10.13 Chicanes

The position of each element of chicanes is marked by a line on the road corresponding to +20 cm around the element.

If one or more elements are moved so much that the element touches or exceeds the line, a penalty is imposed.

Judges of fact monitor chicanes. Judges of fact are appointed in a bulletin before the start time of the first competitor on the first special stage.

10.14 Procedure for special stages of circuit type

10.14.1 Start

The timekeeping (Start) is at the actual start of the car. The start interval shall be in general 1 minute or more. For

safety reasons the interval may vary but the minimum interval will always be 40 seconds.

10.14.2 Stop

At the "STOP" the start time and the actual driving time will be showed in the rallysafe unit. The co-driver can entered the team in the time card for owned use.

In order to calculate the right time for entering next time control, use only hours and minutes of the given starttime,

not seconds and parts hereoff.

10.14.3 Number of laps

In the special stages of circuit type the competitors are responsible for keeping the exact number of laps, which is clearly indicated in the road book. In case of exceeding the number of laps the actual driving time including the time for the exceeded laps will be counted.

In case of less number of laps, the driving time counted will be the slowest time of either the time recorded by the competitor himself or the slowest time in general + 60 seconds. The slowest time in general is the slowest recorded time of all competitors, who has completed the required number of laps.

If the stewards consider the slowest time in general to be too abnormal, they are allowed to, as they see fit, to chose whichever time of the slowest four recorded times to be used as basis for the calculated time.

12. Prizes

12.1 Prize giving

The prize giving will according to these championship rules Art. 3 (following the provisional final classification)

General classification: 1st Trophy

2nd Trophy 3rd Trophy

Class results: up to and incl. 4 starters 1st Trophy

up to and incl. 6 starters 2nd Trophy up to and incl. 9 starters 3rd Trophy over 9 starters 4th Trophy

13. Final Checks

The final checks will take place at: See programme (Art 3)

Cars involved in final checks (at the discretion of the Stewards and notified to the participant at the last TK) must be accompanied by the crew and a mechanic (if dismantling is required).

13.2 Protest Deposit Fee

The protest deposit set by DASU is DKK 750 to be paid in cash when the protest is lodged.

13.2.1 Additional Deposit Fees

If a protest requires the dismantling and re-assembly of parts of the car, an additional deposit must be paid.

Is the protest referring to a clearly defined part of the car (engine, transmission, steering, brake system, electrical system, chassis, etc.) a deposit of DKK 4,500 is paid.

Is the protest referring to the entire car a deposit of DKK 45,000 is paid.

Expenses incurred is borne according to DASU Adm. Cir. I4.

14. Appeal

14.1 Appeal Deposit

The deposit for a national appeal is DKK 6,000. The deposit for an international appeal is EUR 5,000.

14.2 Appeal Deadlines

The deadline for appeals to the DASU national court of appeal is 14 days after publication of the decision being appealed.

The deadline for appeals of decisions issued on the day of the competition by the jury, steward or clerk of the course is, however, no later than 7 days after publication of the decision that is to be appealed, as the appellant must, however, notify the jury, steward or clerk of the course in writing of their intention to appeal within one hour of the publication of the decision and that the appeal deposit will be paid as specified in clause 14.3

14.3 Appeal Procedure

An appeal to the DASU national court of appeal is submitted in writing and signed by the appellant to the secretariat of DASU. The deposit should be enclosed.

Bank transfer of the deposit on the same day as sending the appeal is considered timely.




