Sportska komisija / The Stewards,

nakon što je primila prijavu od vođitelja TKO, razmotrila je sve dobivene informacije te odredila sljedeće /  
having received a report from Chief Scrutinner, have considered the following matter and determine the following:

**Činjenice/Facts:** Tijekom rutinskih pregleda na stopu nakon BI 9, zatečen je SB 43 kod kojeg upravljačka jedinica sustava za gašenje nije bila ispravna te je upozoren od strane tehničke komisije. Ponovnom kontrolom na VK 10D kvar nije uklonjen.  
During routine checks at the stop control after SS 9, Competitor SB 43 was found to have a malfunctioning fire suppression system control unit and was warned by the Scrutineers. Upon re-inspection at TC 10D, the defect had not been rectified.

**Prekršaj/Offence:** Kršenje Članka 253-7.2. Dodatka J FIA ISC-a za 2026  
Breach of Article 253-7.2. of Appendix J to the 2026 FIA International Sporting Code

**Odluka/Decision:** **Kazna od 100 € za natjecatelja SB 43 ŠD GAS KRAS**  
**Fine of 100 € on Competitor No 43 ŠD GAS KRAS**

**Razlog/Reason:** Kako je propisano čl. 4.5.1 Dodatka J FIA ISC-a za 2026., sustav mora raditi u svim položajima. Članak 253-7.2 Dodatka J FIA ISC-a za 2026 ne navodi kada se sustav može uključiti ili isključiti. Iz tog razloga mora uvijek biti aktivan tijekom relija. Sustav za gašenje požara glavna je sigurnosna stavka za zaštitu posade u slučaju požara u automobilu i neophodan je za sigurnost posade. Sigurnost ostaje ključni izazov te su HAKS i FIA predani učiniti sve što je moguće kako bi zaštitili, među ostalima, posadu. Sportska komisija stoga zaključuje da je ovo kršenje čl. 253-7.2 Dodatka J FIA ISC-a za 2026.

As stipulated in Art. 253-7.2.4 of Appendix J to the 2026 FIA International Sporting Code, the system must work in all positions. Art. 253-7.2 of Appendix J to the 2026 FIA International Sporting Code does not specify when the system can be switched on or switched off. For this reason, it must always be active during the rally. The fire extinguishing system is a major safety item to protect the crew in case of fire in the car and it is essential for the crews' safety. Safety remains a key challenge and the CAKF and FIA are committed to do everything possible to protect, among others, the crew. The Stewards therefore conclude that this is a breach of Art. 253-7.2 of Appendix J to the 2026 FIA International Sporting Code.

Posada se podsjeća kako ima pravo na apel na Odluku Sportske komisije u skladu sa Čl. 15 2026 FIA International Sporting Code i poglavlja 4. FIA Judicial and Disciplinary Rules.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Art. 15 of the 2026 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
