Sportska komisija, nakon što je zaprimila izvještaj od Direktora rally-a je razmotrila nastalu situaciju te odredila sljedeće / The Stewards, having received a report from the Clerk of the Course, have considered the following matter and determine the following:

**Činjenice/Facts:** Zbog velike prometne gužve na etapi prema TC2A, direktor rallya zatražio je da se sve kazne na cesti do 5 minuta za kašnjenje na TC2A neutraliziraju za sve natjecatelje, jer se ciljano vrijeme nije moglo postići uz poštivanje prometnih propisa.

Facts Decision Reason Due to heavy traffic congestion on the liaison section to TC2A, the Clerk of the Course requested that all road penalties up to 5 minutes for lateness at TC2A be waived for all Competitors, as the target time could not be achieved while respecting road traffic regulations.

**Odluka/Decision:** **Vremenske kazne do 5 minuta za kašnjenje na TC2A neutraliziraju se za sva vozila pogođena prometnom gužvom.**

**Time penalties of up to 5 minutes for lateness at TC2A are cancelled for all cars affected by the traffic congestion.**

**Razlog/Reason:** Sportska komisija, u skladu sa svojim ovlaštenjima predviđenim člankom 11.7.1.a FIA ISC-a i člankom 1.1.6 2026 FIA RRSR-a iz 2026., odlučila je prihvatiti zahtjev.

The Stewards, under their authority provided by Art. 11.7.1.a of the 2026 FIA International Sporting Code and by Art. 1.1.6 of the 2026 FIA RRSR, decide to accept the request.

Posade se podsjećaju kako imaju pravo na apel na Odluku Sportske komisije u skladu sa Čl. 15 2026 FIA International Sporting Code i poglavlja 4. FIA Judicial and Disciplinary Rules.

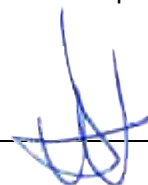
