Sportska komisija je zaprimila izvještaj od Direktora rally-a kako je posadi SB 35 upisana penalizacija od 3 minute za raniji ulazak na vremenskoj kontroli 4A te da ista nije vidljiva u vremenskom kartonu uslijed ljudske pogreške suca. Sportska komisija pozvala je predstavnika natjecatelja na saslušanje, no isti se nije odazvao. Nakon razmatranja predmetne situacije Sportska komisija je odredila sljedeće / The Stewards have received a report from Clerk of the Course that Car No 35 was given a 3-minute time penalty for early check in at TC 4A and that this time penalty is not visible on the time card due to human error by marshal. Team representative was summoned but did not attend. After considering the matter, the Stewards have determined the following:

Činjenice/Facts:	Posada SB 35 je ušla u vremensku kontrolu 4A 3 minute ranije / During the TC4A crew No 35 entered 3 minutes earlier.
Odluka/Decision:	1. Potvrđuje se penalizacija s vremenske kontrole 4A, a koja je dodjeljena sukladno čl. 19.3.3. FIA RRSR Sportskog pravilnika za 2026. i čl.44.2.10 FIA RRSR 2026. / The time penalty from Time Control 4A remains in force due to Art. 19.3.3. 2026 FIA Regional Rally Sporting Regulations and Art.44.2.10. FIA RRSR 2026 2. Opomena za natjecatelja SB 35 sukladno čl.12.4.1.a Dodatka J FIA ISC 2026. zbog nedolaska na saslušanje na poziv Sportske komisije / Warning to Competitor No 35 in accordance with Art. 12.4.1.a of the 2026 FIA International Sporting Code for failing to attend the Stewards hearing when summoned.
Razlog/Reason:	Nakon razmotrenih okolnosti Sportska komisija donijela je odluku kako se penalizacija potvrđuje sukladno čl, 19.3.3. FIA RRSR Sportskog pravilnika za 2026. i čl.44.2.10 FIA RRSR 2026. Zbog nedolaska posade/predstavnika natjecatelja na saslušanje, Sportska komisija izdala je opomenu natjecatelju SB 35 sukladno čl.12.4.1.a Dodatka J FIA ISC a za 2026. After considering the circumstances the Stewards have decided that the time penalty remains in force in accordance with Article 19.3.3. 2026 FIA Regional Rally Sporting Regulations and Art.44.2.10. FIA RRSR 2026. Due to the failure of the crew/team representative to attend the Stewards hearing, the Stewards have issued a warning to Competitor SB 35 in accordance with Article 12.4.1.a of Appendix J to the FIA International Sporting Code 2026.

Posada se podsjeća kako ima pravo na apel na Odluku Sportske komisije u skladu sa Čl. 15 2026 FIA International Sporting Code i poglavlja 4. FIA Judicial and Disciplinary Rules.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Art. 15 of the 2026 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
