The Stewards, having received video evidence on an incident concerning Car No. 6 on SS14, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

**Facts** The driver of car No. 6 was not correctly wearing the required safety clothing (gloves removed) at the stop control of SS14.

**Offence** Breach of Appendix L, Chapter III, Art. 2 of the 2023 FIA International Sporting Code as well as Art. 53.1 of the 2023 FIA WRC Sporting Regulations

**Decision** **Fine of € 200** on driver DANIEL SORDO

In accordance with Art. 12.8 of the 2023 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Reason** The Stewards heard from the driver Mr. DANIEL SORDO, the Co-driver Mr. CÁNDIDO CARRERA of Car No. 6 and the Team Manager Mr. TOLGA OZAKIMCI of HYUNDAI SHELL MOBIS WORLD RALLY TEAM on Saturday 3<sup>rd</sup> June 2023 at 20:55 hrs.

The driver stated that they were very concentrated throughout the stage and that the car got very hot during the stage. He admitted he had made a mistake and apologised for this lapse.

The Stewards nevertheless conclude that protective clothing has to be worn correctly on a special stage until the stop control for safety reasons and decide to apply a fine in this case.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2023 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
