

#### INTRODUCTION

Name of the event: Date of the event: 1<sup>st</sup> RALLY 4 PASSION – HUY – NAMUR 26 – 27 APRIL 2024

The Automobile Club Namur is organizing the first edition of the **"RALLY 4 PASSION Huy-Namur Rallye Festival"** on 26 and 27 April 2024. This event is a motoring demonstration on closed roads of legendary competition vehicles, reserved for a selection of them, without any notion of timing or ranking. It is organized as an annex to the 41st edition of the "RALLYE DE WALLONIE" (event eligible for the "KROON OIL Belgian Rally Championship 2024") and uses the same route for the 2 loops on Saturday 27 April 2024.

On Friday 26 April 202, a prologue dedicated exclusively to the "RALLY 4 PASSION Huy-Namur Rallye Festival" will be held in the early evening in the commune of Huy (Ben-Ahin).

This event is not a speed test, but a demonstration with the sole objective of nostalgia and the notion of pleasure, without taking unnecessary risks or time; the aim is to drive at your own pace on safe demonstration routes. A maximum of two people will be allowed on board.

# 7 AUTHORISED VEHICLES

Original cars or replicas that have written the history of international rallying and were produced before 31/12/2021 are eligible. A Selection Committee will validate the eligibility of vehicles on the basis of their interest and their historical conformity. It will qualify them with the following statuses:

- **ORIGINAL**: original historic rally cars.
- **REPLICA:** historic rally cars identical to the originals.
- **HISTORIC:** rally cars of particular historical interest but not corresponding to an original model. These cars must be selected by the Selection Committee.

"Rally1", "Rally2", "Rally3", "Rally4", "Rally5" and "R-GT" cars (with some exceptions) are not admitted.

The organizer reserves the right to refuse an entry if the vehicle does not comply with the spirit of the Festival.

Vehicles must be insured and comply with the road traffic regulations. The organizers decline all responsibility in the event of any infringement.



As the event is organized under the auspices of the Belgian national motor sport federation, the Royal Automobile Club Belgium (RACB), all crew members must hold a national rally licence.

Note: The RACB offers an annual 'Rally Demo Pass' licence, which does not require any competition experience but only a medical certificate stating that there are no contraindications to driving in sport. This licence is also available in "One Event" form and can be purchased for 70 euros for participation in the "RALLY 4 Passion Huy-Namur Rallye Festival" only.

The event is also open to foreign licence-holders holding a "National" or "International" licence, on condition that a certificate issued by their parent ASN, authorizing them to take part in the event concerned, is attached to their entry.

A permanent authorization from the ASN appearing on the licence is also acceptable. These foreign participants will then be admitted to the start under cover of their foreign licence only.

Note: Foreign participants who do not hold a licence may also acquire the RACB "One Event" licence for demonstration/Festival events.

# 9 FUEL

All competitors may only refuel in the refueling zone. Refueling is strictly forbidden in the service zone, on pain of exclusion.

There will be two refueling zones (see Road-book).

For vehicles using commercially available fuel dispensed directly into the competition car's fuel tank, refueling may take place at the service stations indicated in the Road Book:

# 10 RECONNAISSANCE OF SPECIAL STAGES

Reconnaissance is not compulsory but is strongly recommended.

Registration for reconnaissance is compulsory and will take place when the Road-books are distributed. During reconnaissance, the road traffic regulations must be respected, in particular the speed limits. Please note that the special stages will be open to normal traffic during reconnaissance. Any speeding during a reconnaissance will result in a fine applied by the Race Director.

#### Reconnaissance can only take place on:

$\triangleright$	Sunday	21 APRIL 2024	(09.30 AM – 08.00 PM) (for Belgian participants)
$\triangleright$	Thursday	25 APRIL 2024	(09.00 AM – 08.00 PM) (for foreign participants)
$\triangleright$	Friday	26 APRIL 2024	(08.00 AM – 12.00 AM) (for foreign participants)



Any infringement and/or non-compliance with the reconnaissance timetable, duly noted and reported to the Race Director by the Police or any other official on the list, will result in a financial penalty of €250, which must be paid before the start of the rally.

# **11** ADMINISTRATIVE CHECKS

Administrative checks will be used to ensure that the vehicle is correctly identified and matches the registration file.

## 11.1 REQUIRED DOCUMENTS

Crew members must be able to present the following documents at the administrative checks:

- ✓ Licence for driver and co-driver;
- ✓ Identity card or passport for driver and co-driver;
- ✓ Valid driving licence for driver and co-driver (drivers and co-drivers not resident in the EU must present a driving licence valid in the EU);
- ✓ ASN authorization for all foreign competitors and/or drivers (if required);
- ✓ Insurance certificate for the rally car ("green" card or other certificate attesting that the policy referred to meets the requirements of the law applicable in Belgium);
- ✓ Registration certificate for the car;
- ✓ Authorization from the owner of the car if he is not one of the drivers;
- ✓ Team mobile phone number (service crew): see form;
- 11.2 <u>TIME AND LOCATION</u>: depending on the time and place of the checks, which will be communicated to participants via the Virtual Notice Board <u>www.r4p.be</u> + SPORTITY (R4P24)

#### 12 TECHNICAL SCRUTINEERING (upon convocation)

Cars may be presented for scrutineering by a team representative.

Each vehicle must be presented for scrutineering at the time it is called, which will be communicated to participants via the Virtual Notice Board (<u>www.r4p.be</u> + SPORTITY: R4P24)

### 12.2 <u>SAFETY</u>

The organizers will carry out checks on the following safety points:

- ✓ Tyres must be in good condition. Slick tyres are forbidden.
- ✓ Brake fluid level and battery securement.
- ✓ Lighting, lights and windscreen wipers must comply with the road traffic regulations.
- ✓ Presence of warning triangle and/or hazard warning lights.
- <u>Roll cage:</u>

A roll bar guaranteeing protection in the event of impact or rollover is required. Original vehicles fitted with a roll bar must at least meet the specifications of the period.

<u>Seats and seat attachment:</u>









Seat fixings must be solid and comply with standards. These fixings will be checked during the technical scrutineering. Buckets seats may be vintage ones, but they must be in a suitable condition.

Safety belts:

FIA-approved 6-point belts are recommended. The seatbelt system must be adapted to the bucket seat design. Seatbelt attachments must be bolted, not welded.

• Fire extinguishers:

The vehicle must be equipped with a fire extinguisher weighing at least 2 kg. It must be securely fixed and accessible to the driver and co-driver. The date of the last inspection must not be more than 2 years old.

Battery:

The battery terminals must be protected against the risk of short-circuit by covering the poles adequately.

• Helmet and balaclava:

Driver and co-driver must wear helmets on closed roads. Wearing a helmet and a fireproof balaclava complying with FIA standards is strongly recommended. A neck and head restraint system (e.g. Hans<sup>®</sup>) is recommended.

At the very least, the helmet used must be CE car or motorbike approved.

<u>Clothing:</u>

Vehicle occupants must wear clothing that completely covers their arms and legs. This clothing must be as non-flammable as possible (synthetic fabrics or materials are prohibited). Fireproof overalls, underwear, shoes or gloves complying with FIA standards are strongly recommended.

Following these checks, the organizer may refuse to allow the start of a vehicle considered not to be in conformity with the regulations, or declare its immediate exclusion if it is deemed to be dangerous, without any compensation being claimed.

## 12.3 SPECIFIC NATIONAL REQUIREMENTS

## Cars registered in Belgium must have a Vehicle Inspection certificate;

Each car must be equipped with a red reflective triangle, 2 safety vests and a first-aid kit that complies with the European road traffic regulations.

Two seatbelt cutters must be on board at all times.

They must be easily accessible to the driver and co-driver seated in their seats, with their seatbelts fastened.

# **13** SAFETY TRACKING SYSTEM (SSS)

# ALL CARS MUST BE FITTED WITH A SAFETY TRACKING SYSTEM (TRIPY) SUPPLIED BY THE ORGANIZER.

The SSS equipment will be distributed at the technical scrutineering against the deposit of a credit card guarantee, which will be reimbursed if the equipment is returned undamaged within the specified time limit.

The procedure and technical requirements are specified in an addendum (VNB – <u>www.r4p.be</u> + SPORTITY: R4P24). The equipment must be installed by the crew in each vehicle in accordance with the documents provided.

Any damage, loss, deterioration or theft of the tracking system remains the sole responsibility of the crew until it is returned in accordance with the regulations, even in the event of going off the road, retirement, disqualification or any other incident during the event.

The complete SSS equipment kit will be dismantled by the organizer in the Parc Fermé at the end of the rally.

In the event of withdrawal or early retirement, the competitor must return the complete SSS kit to **<u>Rally HQ/CFR BOUGE</u>** during opening hours.



# 14 SERVICE PARK

Service Park:

The Service Park will be located in JAMBES.

#### Reservations for the Service Park can be made at: (www.r4p.be - R4CE-platform before 21/04/2024 (12.30 AM)

All teams must provide an operational fire extinguisher of at least 6 kg, visibly positioned in the service area, for the time required to carry out any work on the car.

The use of a ground sheet is compulsory (+ night park/ENHAIVE).

No storage of fuel of any kind whatsoever will be permitted in the Service Park and in the assistance areas or in the service and/or auxiliary vehicles. Fuel will be confiscated and a fine of €500 will be imposed by the Race Director.

It is strictly forbidden to enter or drive a vehicle carrying fuel in the Service Park.

#### • Night Park = OBLIGATION TO PLACE A GROUND SHEET/TARPAULIN UNDER YOUR VEHICLE

#### SERVICE AREAS:

The organizer will mark out and number the service areas.

The organizer will inform each competitor of the location of his "service area" when the equipment and documents are distributed.

Any installation that does not comply with the dimensions and location assigned by the organizer will be dismantled and removed at the competitor's expense.

#### ACCESS TO THE SERVICE PARK: The Service Park will be accessible to:

• Assistance vehicles with a "SERVICE" pass: one vehicle per "team"

<u>REMINDER</u>

- "AUXILIARY" vehicles do not have access to the Service Park and must only be parked in the car park reserved for them.
- For vehicles with the distinctive sign "RECONNAISSANCES AUTORISEES" and "AUXILIARY", entry to the assistance zone is strictly forbidden with these passes.
- NON-COMPLIANCE WITH THESE INSTRUCTIONS = €200 fine

## **CLEANLINESS**

In the service park, it is compulsory to use the bins and containers provided for this purpose by the organizers. It is forbidden to throw tyres or pieces of glass into these bins.

#### FIRE PREVENTION

In compliance with the municipal fire prevention regulations: It is forbidden to use "open flame" heating and cooking appliances. This includes campers, barbecues, etc. The use of gas cylinders is PROHIBITED.

#### **ELECTRICITY**

- TEAM: See the "ORES" order form
- CAR: Electricity package = €30 per car
