#### **Competitor Route Day 1**

Transport from Gympie Showgrounds using Exhibition Road (Southside), Eel Creek Road and Schacht's Creek Road to State Forest Entry on Schacht's Creek Road.

#### Special Stage 1 & 5 (Langshaw)


- Using (unnamed) State Forest Road to the junction of Heathcote Road.
- Heathcote Road to the Country Music Muster site.

Then transport using:

Amamoor Creek Road, then turning right in Woodland Road.

#### Special Stage 2 & 6 (Amamoor)

 Using Woodland Road, Bellbird Road and unnamed forest roads within the Amamoor State Forest to Colburn Road (Upper Kandanga).

#### Then transport using:

- Upper Kandanga Creek Road to Neilson Road (Kandanga).
- Neilson Road to Sterling Road.
- Sterling Road to the Kandanga Creek Hall.

#### Special Stage 3 & 7 (Kandanga)

- Starts adjacent to the Kandanga Creek Hall.
- Sterling Road to the junction of Ernst Road.
- Ernst Road to the junction of Melawondi Road.
- Melawondi Road to the entrance to Melawondi State Forest.
- Unnamed State Forest Roads to Mitchell Creek Road.
- Mitchell Creek Road to the junction of Branch Road.
- Branch Road and unnamed state forest roads to the junction of Yabba Creek Road (Imbil).

#### Then transport using:

Yabba Creek Road, to State Forest entrance (Old Forest Drive, Borumba Dam)

#### Special Stage 4 & 8 (Imbil)

 Uses Old Forest Drive, Derrier Road, Casey's Gully and unnamed state forest roads to Western Creek Road (Imbil).

#### Then transport using:

- Imbil-Brooloo Road.
- Mary Valley Highway to Power Road (Southside).
- Power Road to Exhibition Road.
- Exhibition Road to Gympie Showgrounds.

#### End of competitor route - Day 1

#### Spectator Route - Day 1

Gympie >> Mary Valley Highway >> Amamoor Township >> Amamoor Creek Road >> junction of Poulson's Road adjacent to the site of the Country Music Muster.

A spectator park is planned within the confines of the country music muster site. Spectators may return to Gympie using reverse route.

#### Competitor Route Day 2 -

- Transport from Gympie Showgrounds.
- Exhibition Road (Southside), Gympie-Woolooga Road to Reid Road (Widgee).
- Reid Road to the Junction of Golden Hills Road (Widgee).

#### Special Stage 9 & 12 (Brooyar Loop)

- Using Reid Road (Brooyar State Forest Road) and unnamed state forest roads to the state forest boundary at Paff Road.
- Paff Road to the junction of Greendale Road.
- Greendale Road to the mailbox of 238 Greendale Road.

### Then transporting using:

- Greendale Road.
- Diggings Road to the junction of Gympie-Woolooga Road (Glastonbury).
- Gympie-Woolooga Road to the turn-off into SF 242 (Glastonbury State Forest).

#### Special Stage 10 & 13 (Glastonbury)

- Using roads within State Forest 242 (Glastonbury).
- Exits onto Little Widgee Road (Widgee).
- Finishes on Little Widgee Road prior to mailbox 255.

#### Then transport using:

- Little Widgee Road.
- Gympie-Woolooga Rd.
- Reid Road (Widgee) to the junction of Golden Hills Road.
- Golden Hills Road to the property grid (I & J Salmon).

#### Special Stage 11 & 14 (Gympie Gold)

- Starts on Golden Hills Road.
- Using Golden Hills Road to Reinke Road.
- Reinke Road to Diggings Road.
- Diggings Road to finish near the junction of Diggings Road East.

#### Then transport using:

- Greendale Road.
- Gympie-Woolooga Road.
- Exhibition Road, to Gympie Showgrounds.



#### **CONDITIONS**

- 1. A person to whom a special event permit is issued must ensure that the conditions of the permit are complied with. Maximum penalty - 20 penalty units;
- 2. Prior to the commencement of the event, all participants and drivers of event support vehicle/s shall be made aware of the terms and conditions of this permit;
- The authorised route shall be followed and no deviations made by participants without prior 3. consultation with local police;
- The event shall only be conducted during the hours of daylight; 4.
- 5. This permit does not exempt participants and drivers of event support vehicle/s from compliance with the provisions of the Transport Operations (Road Use Management - Road Rules) Regulation 2009 nor any other legislation (unless expressly stated in this permit);
- 6. The issue of this permit does not exempt the applicant from obtaining any relevant permit or authority required by another authority, occupier or owner, e.g. Local Government, Department of Transport and Main Roads, private property owner, lease holder, etc.;
- 7. Participants and drivers of event support vehicle/s shall take all necessary precautions to avoid any road incidents and shall immediately obey any lawful direction given by a police officer:
- 8. Participants shall keep as far as practicable to the left side of the roadway;
- 9. Participants shall drive no more than one abreast at any time, unless passing another participant;
- Event support vehicle/s designated by the applicant as safety vehicle/s, shall operate a flashing yellow/amber light affixed to the roof of the event support vehicle;
- Event vehicle/s designated by the applicant as safety vehicle/s shall travel independently of the participants and shall not impede, obstruct or otherwise interfere with the effective flow of traffic;
- 12. In heavy traffic, all event support vehicle/s shall travel independently of the participants;
- Should more than four (4) vehicles be adversely delayed behind the event, participants and event support vehicle/s shall move to the left of the roadway, pausing if necessary, until the traffic build-up has cleared;
- The event shall be temporarily suspended by the applicant, participant/s or police if undue traffic delays are experienced along the route. The suspension shall be for as long as it takes to clear the traffic build-up:









- 15. The applicant shall ensure that the event is either suspended or cancelled if for any reason there is a danger to participants, other road users or the general public e.g. heavy rain, fog, serious accident, etc.;
- 16. Where participants are unable to proceed due to adverse or unsafe conditions, or official signs prohibit cyclists, event support vehicle/s shall convey participants to a location;
- 17. All stoppages along the route shall be conducted in places that are located off the roadway e.g. parks, rest areas, etc.;
- 18. All Event Marshals are to be identifiable by wearing of either a yellow or orange fluorescent safety vest;
- 19. The applicant shall ensure that children participating in the event are fully supervised and closely monitored by responsible adults at all times.
- 20. The applicant shall ensure that any animals involved in the event are under the control of a suitably qualified handler at all times.
- 21. The applicant shall ensure that an operational mobile telecommunications device is carried in each of the event support vehicle/s.
- 22. The applicant shall ensure that basic first aid supplies are carried in each of the event support vehicle/s;
- 23. This permit may be cancelled, or the conditions altered by a police officer for the safe and effective regulation of traffic, or the safety of the general public and participants;
- 24. No fund-raising shall be conducted from the roadway;
- 25. Suitable public liability insurance should be arranged to cover this event;
- 26. The applicant shall ensure that a contact list is provided to the Police Planning Officer to ensure adequate two-way communications between Police and event staff;
- 27. A copy of this permit (and any associated permits) shall be held by the applicant during the event and shall be produced to police if required.

In respect of the permit application you gave, regarding a proposed special event, you are advised that I, Grantley MARCUS in my capacity as a Superintendent of Traffic within the meaning of the *Transport Operations* (Road Use Management) Act 1995, do not oppose the holding of the special event in accordance with the particulars provided in this notice.


