Sportska komisija, nakon što je zaprimila izvještaj od Direktora rally-a kako se posada SB 21 na BI 10 Ozalj – Ribnik 3 nije zaustavila na Stop Kontroli te se na istu kontrolu vratila vožnjom unatrag, telefonski je nazvala i saslušala natjecatelja Daria Merlića, razmotrili su nastalu situaciju te odredili sljedeće / The Stewards have received a report from Clerk of the Course that during the SS 10 Ozalj – Ribnik 3 crew No 21 did not stop at the Stop control and return to the same control driving reverse, summoned and heard the competitor by telephone, have considered the following matter and determine the following:

**Činjenice/Facts:** Posada SB 21 na BI 10 Ozalj – Ribnik 3 nije se zaustavila na Stop Kontroli te se na istu kontrolu vratila vožnjom unatrag / During the SS 10 Ozalj – Ribnik 3 crew No 21 did not stop at the Stop control and return to the same control driving reverse.

**Prekršaj/Offence:** Kršenje članka 34.1.5 RRSR 2026. i članka 22 Dodatka A03 Pravilnika o autosportovima 2026 / Breach of Art. 34.1.5 RRSR 2026. and Art. 22 of Croatian Rally Regulations 2026

**Odluka/Decision:**  
**1) Ukor za natjecatelja SB 21 / Reprimand to Competitor No 21**  
**2) Novčana kazna u iznosu od 200 € SB 21 / Fine of 200€ to Competitor No 21**  
**3) Vremenska kazna od 2 min na TC 10A SB 21 / 2 min time penalty to be applied at TC 10A to Competitor No 21**

Sukladno čl. 12.8 FIA ISC-a za 2026., novčane kazne moraju se platiti u roku od 48 sati od njihove obavijesti. Svako kašnjenje u plaćanju može dovesti do suspenzije tijekom razdoblja u kojem kazna ostaje neplaćena.

In accordance with Art. 12.8 of the 2026 FIA International Sporting Code, fines shall be paid within 48 hours of their notification. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

**Razlog/Reason:** Nakon telefonskog saslušanja natjecatelja, Daria Merlića, te razmotrenih okolnosti o težini kazne uz činjenicu da prilikom prekršaja nije bilo ugroze, kao i da su se natjecatelji ispričali svjesni svoje pogreške, Sportska komisija donjela je odluku o sljedećim kaznama: ukor, novčana kazna u iznosu od 200€ te vremenska kazna od 2 min na TC 10A sukladno člancima 12.4.1.b. 12.4.1.c i 12.4.1.h FIA ISC-a za 2026.

After telephone hearing the Competitor , Dario Merlić, and considering the circumstances regarding the severity of the penalty taking into account that no danger was caused during the infringement and that the Competitors apologized, acknowledging their mistake the Stewards have decided to impose: reprimand, fine of €200, and 2 min time penalty to be applied at TC 10A in accordance with Articles 12.4.1.b. 12.4.1.c i 12.4.1.h of the FIA International Sporting Code (ISC) for 2026.
