

# 2025 David O'Mahoney Electrical Services Sean Conlon Memorial Forestry Rally



## Final Instructions #3: Refuelling

A refuel area will be in operation at the event in accordance with Motorsport Ireland refuelling guidelines and regulations. The event refuel zone is based in the **Old Galtee Car Park (52.272400, -8.272682)** in Mitchelstown, on the road section between Service Out and SS1/4. There will be strictly **NO REFUELLING** allowed within the main service area. This will be strictly monitored for compliance. The crew **must exit** the car during the refuelling process. There is strictly **no smoking** within the refuel zone. Access to the Refuel Zone is restricted to competing crews and/or their service/refuel crew as required.

### Refuel Zone Operational Information:

- There will be 5 numbered Refuel Bays set up in the Refuel Area, numbered Bays 1 to 5.
- Bay 1 will refuel cars with competition numbers ending with 1 & 6
- Bay 2 will refuel cars with competition numbers ending with 2 & 7
- Bay 3 will refuel cars with competition numbers ending with 3 & 8
- Bay 4 will refuel cars with competition numbers ending with 4 & 9
- Bay 5 will refuel cars with competition numbers ending with 5 & 0

For crews fuelling at the Nominated Commercial Fuel Station along the rally route, there is one fuel station permitted for use, located between Service Out and SS1. The route to this fuel station is included in the Road Book:

- Maxol Service Station, Dublin Rd, Mitchelstown, Co. Cork, P67 HE09.

Crews will be required to complete an RF1 Form at documentation sign on and return form to Rally Office Personnel (copy of form attached below).

**We ask all competitors to enter Parc Ferme fuelled where possible.**

The Club Appointed Refuel Area Manager is Liam Tarrant (086 441 3654) and the Motorsport Ireland Compliance Officer is Barry Duggan (087 995 6312).

- You must switch off the engine and exit the car while it is being refuelled.
- There is no pouring of fuel; It must be pumped. (No Jerry Cans)
- A balaclava and gloves must be worn while the car is being fuelled.
- Strictly NO SMOKING or VAPING in the refuelling area.
- If fuelling at a commercial filling station, please fill out the form RF1 and return it to the rally office when signing on.
- Ground sheets are not required for the Refuel Area by the competitors and will be supplied by the organisers; however, they are required for the service area as per event regulations.
- We recommend bringing trolleys to transport fuel for the Refuel area.
- We advise having the car fully fuelled before scrutiny, as this will save you needing refuel before the first loop.
- Competitors are responsible for ensuring their crew follow the regulations, which are available on Motorsport Ireland website.
- Thanks for your cooperation and have a safe and enjoyable event.
