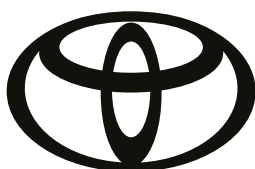

RALLY SWEDEN 2026 will be run in compliance with the 2026 FIA International Sporting Code and its appendices, the 2026 FIA World Rally Championship Sporting Regulations, the National Sporting Regulations which comply with the FIA regulations and these Supplementary Regulations. Modifications, amendments and/or changes to these Supplementary Regulations will be announced only by numbered and dated Bulletins (issued by the organiser or the Stewards).

Additional information will be published in Rally Guide 2, issued on 15 January 2026. Rally Guide 2 has no regulatory value, except as stipulated in Art. 12.18 in these Supplementary Regulations.

2.9 Communication and the Official Notice Board

During the event, individual and general communication between all Rally Officials (Rally Control/COC, Rally Secretariat, CRO, Stewards, Technical Staff etc.) and the competitors/crew members will primarily and as far as possible be conducted via Sportity App.

For this purpose, each competitor is required to nominate ONE official representative authorised for the purpose of receiving any official notifications. As some of these notifications can be issued while rally cars are on stages, this person can neither be the driver nor the co-driver. This person should be a team representative who is based in the Service Park during the event.

As provided for in 2026 FIA International Sporting Code, Art. 11.9.4, the Official Notice Board will be the Digital Notice Board ([DNB](#)), available in the Sportity App and published also on the rally website at rallysweden.com. There will be no physical official notice board. All competitors will be informed only by Sportity notifications about the publication of any documents on the Digital Notice Board. 4. ENTRIES

4.1 Closing date for entries

The closing date for entries is Tuesday 13 January 2026 at 23:59 (CET).

4.2 Entry procedure

Manufacturers, WRC2, WRC3, Junior WRC and Masters Cup competitors who wish to score points in their Championships in Rally Sweden 2026, must make their entries by using the electronic standard rally entry form for their Championships available in the FIA application at <https://registrations.fia.com/rally>.

Any non-priority competitor wishing to take part in Rally Sweden 2026 must register and fill in the electronic entry form published at <https://registrations.fia.com/wrcswe> duly completed before the closing date for entries.

Please note that as the FIA system requires a user ID and a password to access the entry system, you cannot leave the entry procedure to the last minute but must give time for the FIA to open you the necessary user account. The user account application can be found through a link from the registration page as given above

By sending an electronic form, the competitor and the crew submit themselves to the sporting jurisdictions specified in the 2026 FIA International Sporting Code and its appendices, the 2026 FIA WRC Sporting Regulations and these Supplementary Regulations.

Each competitor is required to submit a scanned copy of their signed FIA entry form in the Online Forms of the Administrative Checks, see Art 10.1.

4.3 Eligible Cars

According to Art. 12.4 of the 2026 FIA WRC Sporting Regulations.

4.4 Entry fees / Entry packages

Swedish VAT is applied to fees relating to access & participation to sporting events, in accordance with the Swedish VAT Act, as the event takes place in Sweden regardless of the customer's country of establishment.

4.4.1 Manufacturers, other WRC cars and competitors in the Support Championships

Entry fees for Manufacturers, WRC Teams and competitors in all WRC Support Championships (i.e. WRC2, WRC3 and FIA Junior WRC) are as stipulated in Appendix VI of the 2026 FIA WRC Sporting Regulations (+ local VAT 6 %).

- *A person holding a FIA International Competitor's Licence, but who is not a member of the crew, and who enters one or more cars, is also considered as a legal entity.*

Private competitor

- *A member of the crew holding a FIA International Competitor's License, who enters his own car and competes under his/her own name.*

Swedish private competitor

- *Non-priority drivers from Sweden, competitor is one of the crew members, holding a valid FIA international competitor's licence*

4.4.3 Reconnaissance Only

4.6 Refunds

Entry fees will be refunded:

- to candidates whose entry has not been accepted
- in the case of the rally not taking place

Organisers may refund 50% of the entry fee to those competitors who, for other reasons of force majeure (duly certified by their ASN), were unable to start in the rally. With the request of entry fee refund the competitor must send the organiser a certificate of force majeure given by his own ASN, before Monday 9 February (start of administrative checks).

5. INSURANCE

5.1 Traffic Insurance

All cars participating in the rally must have a valid obligatory traffic insurance towards third parties. In Sweden, the “Green Card” (International Motor Insurance Card) system is applied. For cars coming from countries outside the Green Card system and EEA-countries, a Nordic frontier insurance must be taken at the border. Traffic insurance guarantee competitor’s cover for civil responsibility towards third parties on road sections. The organiser will issue third party insurance cover for foreign registered cars valid on special stages (incl. shakedown).

5.2 Insurance amounts

Maximum compensation in case of damage is SEK 300 000 000.

Maximum compensation regarding organiser liability insurance is SEK 290 000 000.

5.3 Limitation of Indemnity

The organiser declines any liability concerning the consequences caused by any fraudulent action taken by the competitor, may this be against the rules and regulations of the rally or against the laws of the country.

Any service vehicles or reconnaissance cars, even those bearing the official identification of the organiser, may under no circumstances be considered as official participants of the rally, hence their insurance policies remain the sole responsibility of the owner.

Competitors are reminded that all vehicles (incl. scooters, mopeds, forklifts, ATVs etc.) used inside the service area must be insured and must only be used on the driveways designated for vehicles, i.e. not in spectator areas or such. Extreme care must be taken when using silent electric vehicles, especially in the inside service areas, as the spectator pathways are very close to the driveways and have no fencing in between.

6. ADVERTISING AND IDENTIFICATION

6.1 Restrictions

All political, religious, or abusive advertising is forbidden.

Advertising for tobacco, tobacco products and smokers’ requisites is forbidden in Sweden. Advertising for alcohol is restricted by law and is not allowed on competing cars, service cars, equipment and/or clothing.

6.2 The organiser's advertising

The organiser’s compulsory advertising is *RALLY SWEDEN* on the roof panel and *Racing Spirit by Umeå* on the doors. There is no optional advertising. See Appendix 4 of these Supplementary Regulations.

6.3 Identification

Competition numbers and rally plates according to the 2026 FIA WRC Sporting Regulations, Art. 27, will be provided by the organiser. See also Appendix 4.

Numbers and plates must be affixed on the rally car before the car is brought to scrutineering and must be visible throughout the duration of the rally.

The following stickers will be affixed to the car by the scrutineers:

- **At scrutineering:** a check card, size 6 cm x 6 cm (at roll-cage driver’s side)
- **Before the start:** a “3 min” or “2 min” sticker (on the roof over the windscreen, co-driver’s side) on cars with intervals of 3' or 2'.

7. TYRES

7.1 Tyres specified for use during the rally.

In addition to complying with Articles 13, 14 & 15 of the 2026 FIA WRC Sporting Regulations, the following types of tyres are confirmed for use:

Cars in classes RC1 and RC2 must use	HANKOOK 160/650R15 Winter i*Pike SR10W
Cars in class RC3 must use	HANKOOK 140/630R15 Winter i*Pike SR10W

All 4WD cars must use tyres from the FIA nominated tyre company HANKOOK.

For all 2WD cars the make and type of tyre is free. However, competitors are reminded to comply with:

- 2026 FIA WRC Sporting Regulations, Art. 13.1.4; Each tyre must have barcode numbers supplied by the 2026 FIA-approved barcode supplier.
- 2026 FIA WRC Sporting Regulations, Art. 13.3.1.
 - At pre-rally scrutineering, the tyre manufacturer will be recorded by the FIA.
 - During the whole rally, all tyres must come from the same tyre supplier.

7.2 Quantity of tyres

The maximum number of tyres for the rally is **28** for Rally1 cars and **26** for all other cars. Tyres used in Shakedown are not included in the above quantities (qty used in Shakedown is free).

7.3 Tyre orders

Tyre orders must be placed no later than on **Thursday 15 January 2026** using the Hankook Order Form (available at the rally website).

7.4 Studded tyres for reconnaissance

Studded tyres may be used during reconnaissance. They must be in conformity with the following regulations (see also Appendix 7):

- The studs shall be solid, cylindrical and flatcut
- The length of the stud is limited to 15 millimeters
- The weight of the stud is limited to 2.5 grams
- The maximum overhang is limited to 2.0 millimetres
- The studs must be mounted into the tyre from the outside
- The number of studs must not exceed 250 per tyre
- The body of the stud must be solid

Any infringement to this rule will be reported to the Stewards.

7.5 Studded tyres during the rally

Studded tyres may be used during the rally. They must be in conformity with 2026 FIA WRC Sporting Regulations Appendix V, (C) (see also Appendix 7 of these Supplementary Regulations)

- The studs shall be solid, cylindrical and flatcut
- The cross section of the studs must form a full circle at every point
- The stud is not allowed to be tubular at any point
- The body of the stud must be homogenous and is not allowed, under any circumstances, to form a tube or hole.
- Maximum diameter of the flange is 9 millimetres
- Minimum diameter of the metal core in the middle of the stud is 2.5 millimeters. It must be cylindrical, homogenous and flatcut
- The length of the stud is limited to 20 millimeters
- The weight of the stud is limited to 4 grams
- The studs must be mounted into the tyre from the outside
- The number of studs must not exceed 20 per any decimetre of the wheel circumference.

Any infringement to this rule will be reported to the Stewards.

7.5.1 Method for checking the number of studs

Measurement will be carried out with a pattern, on a non-pressured part of the tyre. The length of the pattern is 30 cm, and within the pattern there must not be more than 60 studs. If the number of studs is more than 60 in a 30 cm sections, a further check will be carried out in the next 30 cm section and the total number of studs in both sections must be maximum 120.

7.6 Tyre Marking Zones

- At the Shakedown (Technical Zone between the TC and Start)
- After TC 0
- After TC 4C, 8D, 11C, 15D and 16C (before the refuel)

8. FUEL

Use of FIA Fuel is mandatory for all FIA Priority drivers. The supplier appointed by the FIA for 2026 is TotalEnergies.

Supply, refuelling services and fuel orders will be handled by Sodifuel.

For environmental and safety reasons, all competitors must refuel in the designated refuel zones. Refuelling is not allowed in the Service Park (no refuel from cans, drums or similar), except as detailed in Art. 58 of the 2026 FIA WRC Sporting Regulations.

8.1 Ordering procedure and price per litre

The fuel order form, available at rallysweden.com must be sent by email to totalenergies-wrc@sodifuel.com.

The cost of the FIA fuel is € 9,95 + VAT per litre. Only pre-payment by bank transfer is accepted. A copy of the transfer must be sent to Sodifuel before the deadline of the orders. In case of questions related to fuel ordering procedures, please contact directly to totalenergies-wrc@sodifuel.com.

8.2 Closing date for ordering FIA fuel

Thursday 15 January 2026.

8.3 Refuelling operations

Crews are required to remain outside their cars during refueling. A member of the crew will open the vehicle to allow the operative to attach the pipework. The crew will be responsible for indicating to the refueller the amount of fuel required. The crew only shall close the vehicle and secure the opening once they are happy that they have the right amount of fuel added. Use of a mobile phone is forbidden at the Refueling Zones.

8.4 Fuel distribution during the rally

Refuel zones will be operational as follows:

Thursday 12 February	Service park 09:00 – 16:00* * Used for shakedown + Section 1 (SS1)
Friday 13 February	Service park (after TC 1B and 4C) Remote refuel Andersvattnet after SS 2 and 5
Saturday 14 February	Service park (after TC 8D and 11C) Remote refuel Vännäs after SS 10 and 13
Sunday 15 February	Service park (after TC 15D and 16C)

8.5 Fuel for non-priority drivers

Non-priority drivers may use either FIA fuel following the same conditions and rules as the priority drivers or commercially available pump fuel.

For non-priority drivers not using fuel from the FIA-appointed supplier the organiser will establish Refuel Points near the designated Refuelling Zones due to the lack of suitable petrol stations along the route. These Refuel Points will comply with all safety requirements applicable to Refuelling Zones, as outlined in Articles 61 and 62 of the FIA WRC Sporting Regulations and in Article 8.3 of these Supplementary Regulations.

Teams' service personnel (max. 2 team members) are permitted to use their own fuel drums and pumps at these Refuel Points. All personnel involved in refuelling operations must wear fire-resistant clothing that offers adequate protection. This includes, at a minimum: long trousers, a long-sleeved top, closed shoes, gloves, and a balaclava.

Service personnel are also responsible for protecting the ground by using an Environmental Mat. This mat must consist of an absorbent upper layer and an impermeable lower layer. No refuelling is permitted without such a ground mat. The use of ethanol is strictly forbidden, except as included in commercially available 95E or 98E pump fuel from service stations.

All non-priority competitors using pump fuel are reminded to pay attention to 2026 FIA WRC Sporting Regulations, Art. 62.3.7: Cars equipped solely with FIA-specified refuel couplings and using fuel as per Art. 62.1.2 must show it at pre-event scrutineering.

9. RECONNAISSANCE

See also Art. 35 in the 2026 FIA WRC Sporting Regulations.

9.1 Procedure for reconnaissance registration

The competitor must send the organiser in advance an information form (see Website/Rally Guide 2) to entry@rallysweden.com, including details of the reconnaissance car, mobile phone number and place where the crew is accommodated. The form must be signed and submitted by Monday 9 February 2026 at the latest.

All reconnaissance and rally materials may be collected at the administrative checks by the nominated competitor representative, holding a written proxy (see Art. 10).

Identification numbers, given at the registration, shall be affixed on the car (windscreen at the top corner, co-drivers side) and kept visible for the duration of the reconnaissance period.

9.2 Participation in reconnaissance only

Any driver holding an appropriate international license but not entered in the rally may apply to take part in the reconnaissance. The regulations on reconnaissance must be respected in their entirety. A registration form for this purpose will be sent on request. The final permission for taking part in recce is left to the discretion of the organiser. An administrative fee will be charged (see 4.3.3 Reconnaissance Only).

9.3 Tracking system for reconnaissance

With reference to Art. 35.4.4 of the 2026 FIA WRC Sporting Regulations, all competitors must make one iOS or Android smartphone available and equip their reconnaissance cars with a smartphone-based application RS Lite developed by the FIA official supplier STATUS AWARENESS SYSTEM (SAS). SAS will distribute individual event access codes during the reconnaissance registration.

Rental of smartphones is also available from SAS, to be requested when completing the access code purchase on the SAS website and collected during the reconnaissance registration.

Access code costs:

- all competitors: € 40 + optional smartphone device rental € 100
- payment must be done online and in advance on the SAS website: <https://wrc.statusas.com/shop/recce/>

The RSLite application must be kept active and the telephone charged at all times when the reconnaissance car is being driven (also on road sections). Any misuse will be reported to the Stewards.

9.4 Specific and national restrictions

9.4.1 Passages

Crews are authorised to drive a maximum of 2 times through each special stage in accordance with the schedules given in Appendix 2. Special stages must be driven in the same direction as the rally, at a reduced speed and fully respecting the Traffic Laws. All special stages are run twice during the rally but may only be driven as one stage during recce. All passages through the special stages will be recorded by the marshals. Timecards will not be used.

9.4.2 Speed limits

The maximum speed allowed during reconnaissance is 70 km/h on special stages unless a lower speed limit is indicated by traffic signs or by written instructions in the Road Book (or in Bulletins). All crews are reminded of Art. 34.2 in the 2026 FIA WRC Sporting Regulations.

9.4.3 Tyres

For reconnaissance tyre regulations see Art. 7.4.

10. ADMINISTRATIVE CHECKS

Administrative checks will be done online, before the event. All required documents as per Art 10.1 must be scanned and sent to the organiser by using the following address: anna.obrand@rallysweden.com latest on 13 January 2026.

Notwithstanding the 2026 FIA WRC Sporting Regulations, Art. 30.1, drivers and co-drivers are not required to report personally to the administrative checks.

Each Competitor shall nominate in advance to the organiser one authorised representative to complete the administrative checks.

10.1 Documents to be presented

- International Competitor's licence
- Driver's and Co-driver's International competition and driving licences
- Driver's and Co-driver's medical certificates of aptitude (if separate from competition licence)
- Driver's and Co-driver's identification cards/passports
- ASN authorisation for all foreign drivers and co-drivers by their ASN, to take part in the rally
- Rally car's insurance cover towards third parties (Green Card)
- Accuracy and completion of all information given on the entry form
- Signatures of entry forms from both drivers and the competitor
- Driver Declaration and undertakings duly signed by the Driver and the Co-Driver
- Car homologation certificate, first page of the car's homologation form with the number (not for Rally1 cars)
- Car registration papers

All the original documents listed above must be brought to the Administrative Checks in case they need to be visually inspected.

The entry form must be signed by all parties and presented in printed format by the representative of the team during the Administrative Checks.

11. SCRUTINEERING

11.1 Venue and Timetable

Sealing and marking of Rally1 cars:

- **Venue:** Individual service bays, Service Park
- **Date and time:** Thursday 12 February from 08:00

Scrutineering / component sealing of all other cars:

- **Venue:** OPUS Bilprovning Umeå-Västerslätt, Mätarvägen 8, [63°51'17.1"N 20°12'32.4"E](#)
- **Date and time:** Wednesday 11 February from 14:00

Detailed timetables will be published in a Bulletin.

Note! Studded rally tyres are forbidden in the workshop at OPUS Bilprovning.

11.2 General requirements

- 11.2.1** Competition numbers and rally plates must be affixed to cars in the stated positions prior to scrutineering. See Art. 6 and Appendix 4.
- 11.2.2** All cars must have a complete certified homologation form available at scrutineering (2026 FIA International Sporting Code, Appendix J, Art. 251.2.1.8). In addition, homologation forms for the catalytic converter and roll cage (if homologated) must be with the car at scrutineering.
- 11.2.3** Sealing of the cars will be carried out according to 2026 FIA WRC Sporting Regulations Articles 16 & 17. Therefore, all underbody protection must be removed for scrutineering, but must be kept with the car for weight checks. Car's chassis and cylinder block will also be marked (2026 FIA WRC Sporting Regulations, Art. 31.1.6). Sealing wires must be installed as instructed by the car manufacturer.
- 11.2.4** After scrutineering, if a car is found not to comply with technical and/or safety regulations, the Stewards may set a deadline to comply with the requirements otherwise start in the event may be refused.

11.3 Mud flaps

Fitting of transversal mud flaps (all wheels) is mandatory in conformity with 2026 FIA International Sporting Code, Appendix J, Art. 252.7.7.

11.4 Windows

The use of transparent and colourless anti-shatter films (maximum thickness: 100 microns) is compulsory on side and sunroof windows, unless they are in polycarbonate (see Art. 253.11 of 2026 FIA International Sporting Code, Appendix J). Window nets are not allowed.

The use of silvered or tinted films is authorised, on the rear side windows, on the rear window and on the sunroof, on the following conditions:

- Silvered or tinted films fitted on rear side windows must have an opening equivalent to the surface of a circle of 70 mm in diameter so that the driver as well as the contents of the car may be seen from the outside.

11.5 Drivers' safety equipment

At scrutineering competitors must produce all items of clothing including helmets and head restraints intended to be used. Condition of the equipment and compliance with 2026 FIA International Sporting Code, Appendix L, Chapter III will be checked. Also, see Appendix 5 of these Supplementary Regulations.

11.6 Noise level

At any time on the road sections, the noise level must be in conformity with 2026 FIA International Sporting Code, Appendix J. See also 2026 FIA WRC Sporting Regulations Art. 18.4.

11.7 Special national requirements

Competing cars must be equipped with two snow shovels, two first aid kits and one reflective triangle.

11.8 FIA Safety Tracking Device (2026 FIA WRC Sporting Regulations Art. 18.2 and 53.2.1)

All competitors must make provisions in their rally cars for the installation of the FIA Safety Tracking Device, and the system must be installed before the car is brought to scrutineering.

No deposit will be collected for the tracking device, but all the damage caused will be invoiced afterwards. Tracking device may be collected either by the crew or a representative.

All priority competitors are required to purchase a SAS RallySafe WRC-spec fitting kit, which will be permanently installed in the vehicle for all World Rally Championship events. Non-Priority competitors, as an alternative to purchasing a RallySafe WRC-spec fitting kit, have an option to rent a kit for the single event, paid and collected at the FIA Safety Tracking Device collection window on the event, and to be returned with the tracker at the completion of the event. For instructions see Appendix 6 of these Supplementary Regulations.

The FIA Safety Tracking Device may be removed in the final parc fermé by a team member under the supervision of a scrutineer. In any case, the device must be returned to STATUS AWARENESS SYSTEM (SAS) truck in Service Park no later than one hour after the Stewards have authorised the opening of the parc fermé.

Should a competitor retire, the tracker unit (and, if rented, the WRC-spec fitting kit) must be returned to SAS office in the Service Park as soon as possible.

11.9 On-board Cameras

The competitor of any car which carries an on-board camera must have the prior agreement of the Promoter.

The fixings of the camera and camera recorder must comply with the 2026 FIA International Sporting Code, Appendix J, Art.253.2.

Competitors wishing to use an on-board camera must apply via the WRC Accreditation Portal at the latest by Monday, 2 February 2026. Any requests presented after this date will not be considered and the competitor will not be authorised to install an OBC on their car.

Those registering for an OBC for the first time should first use this link: <https://qrco.de/WRCOBCRegistration>

Those who have already applied for an OBC in the last 12 months should use their e-mail address to register via this link (no password required): <https://qrco.de/OBCForm2026>

An authorization sticker, which must be affixed to the car in the vicinity of the authorised camera prior to Scrutineering, must be obtained from the HQ when collecting documents and other materials (Art 10.2).

Any contacts about OBC prior to the event should be addressed to Miguel Fonseca, accreditation@wrc.com.

12. OTHER PROCEDURES

12.1 FIA eLearning course and Drivers' Safety Briefing

All drivers and co-drivers who have not yet participated in any WRC event in 2026 must complete the FIA eLearning course and pass the assessment for FIA Safety Tracking Device by Monday, 9 February 2026, 21:00 hrs and are required to attend the Drivers' Safety Briefing on Tuesday, 10 February 2026 at 17:30 at the Media Centre.

Instructions for the eLearning course will be sent to the competitors by email once the Entry List is published.

12.2 Shakedown

See Article 36 of the 2026 FIA WRC Sporting Regulations.

All P1 and other requested drivers will be required to complete their first passage of Shakedown according to the Start List that will be published on Wednesday, 11 February at 17:00 hrs.

- FIA P1 drivers shall complete a minimum of 2 passages in total of the Shakedown
- FIA P2, P3 and P4 drivers must complete at least one passage of the Shakedown and maximum of two passages
- Participation is optional for non-priority drivers, and they are permitted a maximum of 2 passages in total of the Shakedown stage.

12.3 Official time used during the rally

Official time throughout the entire rally will be that of GPS (UTC time + offset to local time).

12.4 Start order and intervals

Start order as per Art. 41.2 of the 2026 FIA WRC Sporting Regulations.

Start intervals are 3 minutes for P1 crews, 2 minutes for P2 crews and 1 minute for all other crews. The Clerk of the Course may, for safety reasons and with the knowledge of the Stewards, reposition drivers or change the time interval between them.

Start intervals for the Power Stage will be defined as per Art. 50.3 of the 2026 FIA WRC Sporting Regulations.

12.5 Control Procedures and Timecard Handling

The complete set of Timecards for the whole rally (including the Shakedown) will be delivered with the rally materials at the administrative checks. It is imperative for all crews to carry at least all the Timecard sets for a whole day inside the car (cf. for example procedures at regrouping controls).

Time control procedures will be as described in 2026 FIA WRC Sporting Regulations, Arts. 43, 44, 46, 48, 49 and 55. Any writing on the timecards can only be done by the rally officials, except filling in the car number and markings on the boxes reserved for competitor's use.

12.6 Start procedure

There will be no ceremonial start in this rally. The official start of the rally will be at TC 0.

A prestart holding area at Red Barn Area will be established before the TC 0, and the crews are requested to be in this area 30 minutes before each car's individual start time.

There will be a prestart show including presentation of cars and drivers selected by the FIA Media Delegate starting from 17:30. Further details will be given in a Bulletin.

12.7 Starting system of special stages.

The standard light sequence mentioned in Article 48.2 and Appendix VII, of the 2026 FIA WRC Sporting Regulations will be used.

Should this start system fail the start will be given as specified in Article 48.3 of the 2026 FIA WRC Sporting Regulations.

12.8 Permitted early check-in

Crews are authorised to check-in early without incurring a penalty at TC 1A (end of Section 1), TC 8C (end of Section 4), TC 15C (end of section 7) and TC 18A (final time control).

12.9 Extra lights

Crews are allowed to remove extra lights in the parc fermé after TC 1A using only tools carried in the rally car and bring them to a team representative.

12.10 Organisers promotional activities

PR activities, crew requirements and related schedule for Wednesday 11 February and Thursday 12 February will be aligned with the P1, P2, P3 and P4 teams ahead of the event. Selected Crews for the activities will be nominated by FIA Media Delegate.

12.10.1 Monday 9 February

A family photo session for all P1 crews and selected crews, as nominated by the FIA Media Delegate, will take place within the time window 20:00–22:00 on Monday 9 February 2026.

The exact start time and meeting point will be confirmed by the FIA Media Delegate and the National Press Officer. The photo is planned to take place in front of the aurora. This activity is weather dependent and may be cancelled.

12.10.2 Wednesday 11 February

The following cars and crews are required to take part to the PR activity taking place on the Umeå City Hall Square as per the below schedule:

- 17:50 Caravan incl. one Rally1 car per P1 manufacturer as well as other selected cars starts from Service Park (cars can be driven by a mechanic). Nominated cars and crews will be announced in a Bulletin.
- 18:00 Above listed cars start the caravan through city center and end up on display.
- 18:20 All P1 crews (drivers and co-drivers) plus other selected crews attend PR activities on stage at the Fan Zone at Rex (City Hall Square, [63°49'31.3"N 20°15'45.9"E](#)) followed by an autograph signing session by the parked cars. The crews will be split in groups rotating between the PR activities and autograph signing.
- 19:00 Displayed cars are driven back to Service Park
- 19:15 Selected crews, as well as team representatives, nominated by the FIA Media Delegate, are required to attend the official meet-and-greet event for a minimum of 15 minutes and be available for live interviews. Exact place and time to be communicated by the FIA Media Delegate and National Press Officer.

12.10.3 Thursday 12 February

All Priority 1 cars and crews, as well as cars and crews selected by the FIA Media Delegate are required for the prestart show and autograph signing at the Red Barn arena on Thursday 12 February. All the requested cars must be present in the Holding Area by latest 17:20 to initiate the line-up. The driver must stay in the car awaiting marshal instructions for the line-up. After cars are parked in line-up order, all crews go for autograph signing. Directly after autograph signing, cars are driven onto the ramp as directed by the marshals for show and interviews and then driven off the ramp back to the holding area before TC 0.

Any further information will be coordinated with the PR representatives by the FIA Media Delegate and Event Media Coordinator.

12.11 FIA Media Pen

The FIA WRC Media Pen will be organized on Thursday, 12 February from 15:00 - 16:30 in the interview area in the WRC Hospitality Hall in the Service Park. The FIA WRC Media Pen is mandatory for all P1 drivers and P2 drivers, as well as P1 manufacturer team representatives, and upon request by the media to the FIA Media Delegate or National Press Officer for all other priority drivers or co-drivers. Attending competitors are required to be present for a duration of 30 min minimum, or until dismissed by the FIA Media Delegate.

12.12 Media Zones

The Media Zone is located at the entry of the Service Park, prior to the Regroup/Service IN. This Media Zone will be operational as follows:

- on Thursday 12 February: inside the Media Centre, after the car is driven into the parc fermé (TC1A)
- at TC4A, 8A, 11A, 15A and 16A
- on Sunday 15 February: the final Media Zone will be held inside the Media Centre, after the car is driven into the final parc fermé.

Additionally, media will be allowed to conduct interviews with the crews in the pre-podium holding area.

All priority drivers (and co-drivers upon request) must be available for media interviews for a minimum of 15 minutes or until they are given permission to leave by the FIA Media Delegate. It is the duty of team/driver press officers to manage the time available appropriately and to be aware of the need to allow for interviews and the giving of relevant information upon request.

Access to the Media Zone is restricted to the following:

- Accredited media or team media personnel holding a green pass
- Team principals or team representatives, who are, in view of the FIA Media Delegate, performing media duties and displaying a Media Zone sticker issued by the FIA Media Delegate for this event on their pass.
- Holders of a red All Access pass

No other personnel will be allowed in the Media Zone unless authorised by the FIA Media Delegate and holding the correct pass and approved access. Requests for the delivery and activation of the NFC sticker (excluding red all access and green media passes) should be sent by email to:

FIA Media Delegate Sven Good, sgood@fia.com, no later than 15:00 hrs on Tuesday 10 February 2026.

12.13 FIA post-event press conference

All winning drivers and codrivers, as well as the representative of winning manufacturer, must complete on-stage interviews as part of the prize giving ceremony, as this will count as the official contribution to the FIA post-event press conference. Although, all drivers and codrivers and team principals, as nominated by the FIA WRC Media Delegate, must attend further peer-to-peer interviews at the Media Centre after the cars have been driven into the final parc fermé. Interviews with the winners in the different classes will be conducted on the final podium.

Crews are kindly reminded of the obligation to be available for media duties, unless dismissed by the FIA Media Delegate, as stipulated in Art. 38.2 of the 2026 FIA WRC Sporting Regulations.

All drivers and co-drivers except top 3 in the overall classification must be available for media interviews in the holding area before the ramp.

12.14 Flexi Service

Services on Friday and Saturday evening are Flexi Services as stipulated in Art. 59 of the 2026 FIA WRC Sporting Regulations.

12.15 Re-start after retirement

With reference to Art. 54 of the 2026 FIA WRC Sporting Regulations any crew which fails to complete a section will be assumed to re-start the rally from the start of the next section following the overnight regroup. If not, they must confirm with the Clerk of the Course by completing the form located in the road book and lodging it with the organiser as soon as possible before the publication of the re-start list.

Any crew re-starting the rally must present their cars at the overnight parc fermé at the latest four hours before the start of the next Section following the overnight regroup.

For cars driven by Priority drivers, a special timecard will be used for the maximum of 3-hour service (4 hours for P1).

12.16 Power Stage

With reference to Art. 50 of the 2026 FIA WRC Sporting Regulations special stage 18, Umeå 2, will be run as the “Wolf Power Stage”. Art. 56.2.2 applies at the regroup TC17A/B and while the crews are waiting before TC17A.

All P1 drivers (and if timing allows, also all other priority drivers) are required to be available for 10 minutes to sign autographs for the spectators after having parked their car at the Regroup area (after TC17A) in the Red Barn Arena.

After having completed the Power Stage, the last of the selected cars for Live TV **must not stop** at the Power Stage stop control nor at TC 18A but drive straight to the holding area and follow the directions of officials to drive the car directly on to the podium. All time control requirements will be completed on the podium.

12.17 Finish procedure

The finish of the competition element of the rally is at TC 18A, at the Red Barn. Thereafter crews must follow the instructions of officials during the podium ceremony.

All P1 crews, all Swedish crews as well as all crews that are awarded prizes must drive through the podium. All other crews may proceed directly to final parc fermé if they do not wish to drive over the finish ramp for a photo opportunity.

From the podium, crews are obliged to drive their competing car to the final parc fermé following the route described in the road book. Between TC 18A and parc fermé, competitors will be under parc fermé conditions and will be observed by marshals. There are no time controls at the podium nor at the final parc fermé, but the maximum allowed time from the podium to the parc fermé is 15 minutes, which will be controlled by the marshals. Any crew exceeding that time will be reported to the Stewards.

Recovery of any competing car which fails to arrive under its own power at the final parc fermé shall be the responsibility of the competitor. The permission of the Clerk of the Course must be obtained before any recovery arrangements are made.

After the podium, cars of those crews required at the FIA post-rally Press Conference, may be driven by a team representative to the final parc fermé.

12.18 Environmental prescriptions

Organiser’s Environmental Policy which will be published in detail in Rally Guide 2, is considered as an integral part of these Supplementary Regulations and all competitors must comply with it.

12.19 Exhibition driving

Exhibition driving ("doughnuts") or any other dangerous driving is strictly forbidden everywhere. All infringements will be penalised with a minimum of a 5-minute time penalty, applied by the Stewards.

15. FINAL CHECKS AND PROTESTS

15.1 Final checks

Post-rally scrutineering will take place on Sunday, 15 February 2026 at Motorcentralen i Umeå, Rothoffsvägen 16.

Cars subject to final checks (COC Individual Communication notified to the competitor concerned at the finish TC) must have one representative of the competitor as well as mechanics and proper equipment (in case of dismantling) present at the final checks.

15.2 Protest deposit (2026 FIA WRC Sporting Regulations Art. 65.2)

The protest deposit is € 1000.

If a protest requires the dismantling and reassembly of a clearly defined part of the car (engine, transmission, steering, braking system, electrical installation, bodywork, etc.), an additional deposit may be specified by the Stewards in accordance with Art. 13.4.3 of the 2026 FIA International Sporting Code.

The expenses incurred in the work and in the transport of the car shall be borne by the claimant if the protest is unfounded, or by the competitor against whom the protest is lodged if it is upheld.

If the protest is unfounded, and if the expenses incurred by the protest (scrutineering, transport, etc.) are higher than the amount of the (additional) deposit, the difference shall be borne by the claimant. Conversely, if the expenses are less, the difference shall be returned.

15.3 Right of review deposit (2026 FIA ISC, Art. 14.4.3)

The right of review deposit is € 1000.

15.4 Appeal fee and deposit

For the applicable **appeal fee** and the applicable **appeal deposit** please refer to the Judicial and Disciplinary Rules of the FIA, available at <http://www.fia.com/international-court-appeal>.

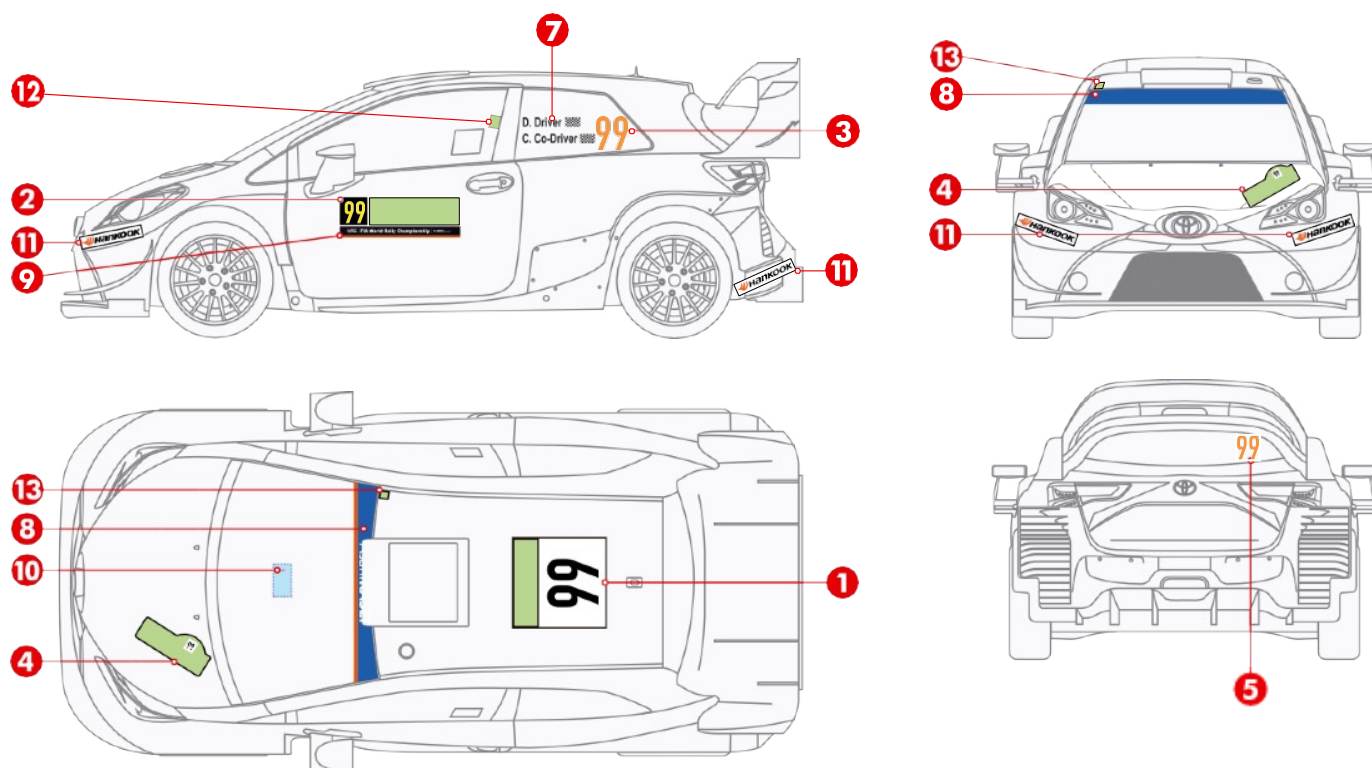

APPENDIX 5 – DRIVERS' SAFETY EQUIPMENT

All competitors are reminded of Appendix L of the 2026 FIA International Sporting Code (ISC), in particular its Chapter III – Drivers' Equipment. These regulations apply to Shakedown as well.

Helmets (2026 FIA ISC, Appendix L, Chapter III, Art. 1)

Priority 1 drivers and their co-drivers must wear helmets according to the FIA standard 8860-2018 or 8860-2018-ABP. This also applies to all Priority 2 crews competing with a World Rally Car.

All other crews must wear crash helmets homologated to one of the following FIA standards:

- 8859-2015 (Technical List N° 49),
- 8859-2024 or 8859-2024 ABP (Technical List N° 107),
- 8860-2010 (Technical List N° 33) or
- 8860-2018 or 8860-2018-ABP (Technical List N° 69)
- see also Technical List N° 25

Drivers and co-drivers who wear full-face helmets must contact the FIA Medical Delegate wrc.medicaldelegate@fia.com or the Chief Medical Officer in order to carry out a test before the start of the event. This test is described in the Appendix L, Chapter III, Art. 1.3.

Frontal Head Restraint (FHR) (2026 FIA ISC, Appendix L, Chapter III, Art. 3)

All crews must use FIA approved FHR systems homologated to FIA standard 8858. Approved FHRs, anchorages and tethers are listed in Technical List N° 29. See also helmet compatibility chart in Appendix L, Chapter III, Art. 3.3.

Flame-resistant clothing (2026 FIA ISC, Appendix L, Chapter III, Art. 2)

All drivers and co-drivers must wear overalls as well as gloves (optional for co-drivers), long underwear, a balaclava, socks and shoes homologated to the FIA 8856-2018 standard (Technical List N° 74).

It is permitted that drivers and co-drivers wear shoes which do not comply with the FIA 8856-2018 standard but are adapted to the weather conditions.

Please pay special attention to the prescriptions of Art. 2 concerning embroidery and printing on flame-resistant clothing (manufacturer certificates etc.) as well as concerning the correct wearing of the clothing elements! See also the 2026 FIA WRC Sporting Regulations, Article 53.1.

Biometric Devices (2026 FIA ISC, Appendix L, Chapter III, Art. 2.1)

Drivers may wear a device to collect biometric data during racing.

- If the biometric device is integrated into a protective garment homologated to FIA Standard 8856, the garment shall be homologated to FIA Standards 8856 and 8868- 2018.
- If the biometric device is a stand-alone device, then the device must be homologated to FIA Standard 8868-2018 only. This device must be worn in addition to the garment homologated to FIA Standard 8856.

Glasses or contact lenses (Appendix L, Chapter III, Art. 1.7)

Only glasses or contact lenses for the sole purpose of correcting eyesight and figuring in the international drivers' licence are authorized.

Wearing of jewellery (2026 FIA ISC, Appendix L, Chapter III, Art. 5)

The wearing of any type of jewellery, such as but not limited to, neck chains, bracelets or watches is prohibited during the competition. Exceptions to this rule, providing the CMO and/or Medical Delegate do not consider that due to size or location they may delay rescue or hinder emergency care, are:

- i. the wearing of watch(es) by co-drivers, on the condition that the watch(es) is worn over the overall,
- ii. the wearing of a single band-style ring providing it does not restrict the natural range of motion of the hand, and
- iii. the wearing of body piercing(s) providing they are not worn in and/or around the oral cavity.

APPENDIX 6 – FIA SAFETY TRACKING DEVICE

All priority competitors are required to purchase a SAS RallySafe WRC-spec fitting kit, which will be permanently installed in the vehicle for all World Rally Championship events. The SAS RallySafe WRC-spec fitting comprises all necessary antennas, mounting and wiring components to be pre-installed in the vehicle, prior to the supply of the FIA Safety Tracking Device and Remote LED Display at the event. SAS RallySafe WRC-spec fitting kit can be purchased via the RallySafe shop (<https://statusas.com/wrc-kit>) and shipped to the competitor prior to the event, or collected at the event, or alternatively purchased onsite when collecting the FIA Safety Tracking Device at the event. The price of the kit is €150.00, excluding shipping and handling fees.

Non-Priority competitors ONLY, as an alternative to purchasing a SAS RallySafe WRC-spec kit, have an option to rent a kit for the single event for the cost of €50.00, paid and collected at the FIA Safety Tracking Device collection window on the event, and to be returned with the tracker at the completion of the event.

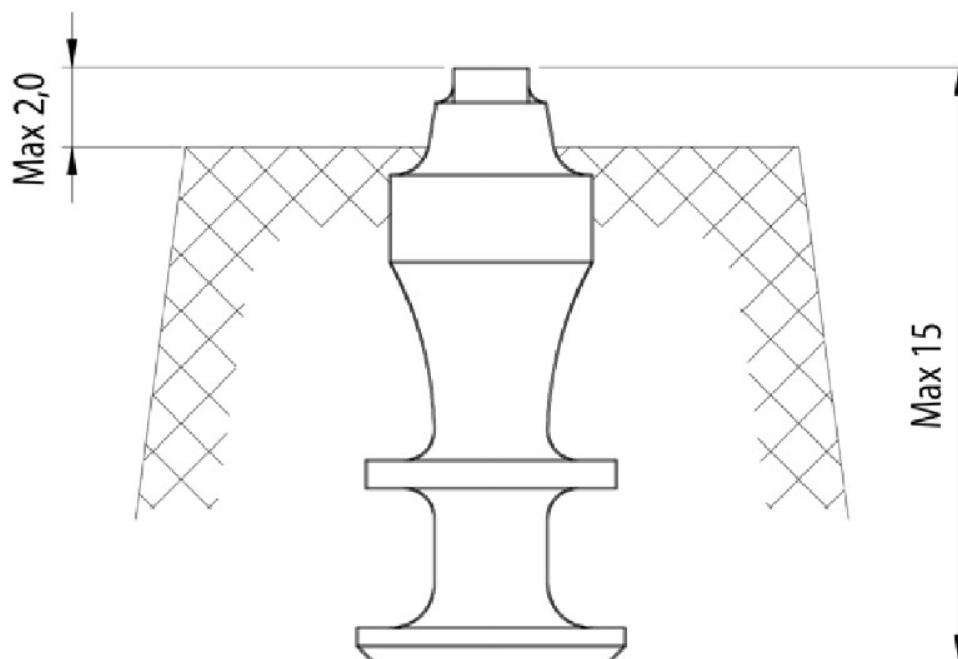
