## ARGYLL AND BUTE COUNCIL (VARIOUS ROADS, MULL) (MULL RALLY) (TEMPORARY TRAFFIC REGULATION) ORDER 2022

Argyll and Bute Council in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended and of all other powers enabling them to do so, being satisfied that traffic on the lengths of road specified in the Schedule hereto should be prohibited or restricted for the purpose of facilitating the holding of a race or trials of speed between motor vehicles on public roads within the Mull area, and being satisfied that it is not reasonably practical for the event to be held otherwise than on a road, and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order and being satisfied that a Motor Sport Order has been made under the Motor Sport on Public Roads (Scotland) Regulations 2019, hereby make the following Order:

- 1. This Order may be cited as the "Argyll and Bute Council (Various Roads, Mull) (Mull Rally) (Temporary Traffic Regulation) Order 2022" and shall be effective when indicated by signs on the dates and times indicated in the Schedule hereto.
- 2. The Interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.
- 3. Subject to Article 4 of the Order, No person shall drive or cause or permit to be driven any vehicle, permit any vehicle to wait or to be parked or ride, or cause to be ridden any cycle, or ride, lead or drive any animal, or walk along the lengths of road as specified in the Schedule to this Order.
- 4. Nothing in this Order shall apply to any vehicle which is:
  - a) being driven upon the direction or with the permission of a police officer in uniform or the event organisers;
  - b) an emergency services vehicle whilst attending an emergency.
