#### 2. This event will count for: :

- Championship of Hungaria: according to national regulations
- Championship of Austria: according to national regulations
- Slovak Autocross Championship: D4,D5, D5-200, D6, , D7, D8, D9

#### 3. Description of circuit

#### 4. Entry forms – Entries

- 4.1 Anybody wishing to participate in the event must send the duly completed electronic application form, which is the official web page [www.sams-asn.sk/prihlaska3.php](http://www.sams-asn.sk/prihlaska3.php) to 14.07.2023 24:00.
- 4.2 In accordance with the regulations of the FIA Central European Zone Championship ,the starting permission for abroad is not obligatory

#### 5. Entry fees

Normal fee : 230,- €, Increased fee: 280,- €  
Normal tee RB: 10,- €, Increased fee RB: 20,-€  
All the fees will be collected during the administrative checking.

#### 6. Insurance

The event is written in the SAMŠ calendar and it is insured against the driver 's responsibility toward third parties.

**Each rider is obliged to take out accident insurance and present the document upon request during the administrative check.**

## **IV. CHECKING**

### **7. Administrative checking**

All drivers must report to administrative checking which will be held at Administrative building – Secretary office on 14. 07.2023 from 16:00 to 20:30. Drivers must submit all valid documents for 2023 year.

### **8. Scrutineering**

Every car taking part at the event must be presented by the rider or his official representative to scrutineering which will be held on 14.07.2023 from 16:15 to 20:45

No cars will be allowed to start unless it complies with the current FIA safety regulations (Appendix J) in races of CEZ and MSR.

## **V. RUNNING OF THE EVENT**

### **9. There will be one free (2 rounds) and two timed practice. In each training run there is a max. 8 vehicles.**

Timed practice is 4 laps from the moment the vehicle crosses the finish line.

Every driver is obliged to participate in timed training. A rider who does not have a single timed lap can only start with the permission of the Decision of the Stewards.

### **10. Qualifications**

There are 3 Heats of Qualifying and each will have 5 laps.( RB 4laps)

Only those competitors who have started in two races and finished at least one with the same number of laps as the winner are classified in the final races.

### **11.. Semifinals and Finals**

Semifinals will be: 6 laps (RB 5laps)

Finals will be: 7 laps. (RB 5laps)

### **12. Start.**

At the beginning of the process, the panel with the inscription READY will be lit, within 5 seconds after the inscription goes out, it will be started, with the green light coming on.

## **VI. PARC FERME - RESULTS – PROTESTS**

### **13 . Parc Fermé**

The Parc Fermé lot will not be organized. The competitor must leave the vehicle at least 30 minutes after the publication of the preliminary final results in the depot without the intervention of mechanics.

### **14. Results**

The results will be posted a.s.a.p. on the official board after each Heat and Final. The Final's cast will be on the official board before the Finals.

### **15. Protest - appeals**

All the protests will be lodged in accordance with the International Sporting Code.

All the protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence to any of the stewards of the meeting, together with the financial sum.

## VII. PRIZES AND CUPS

### 16. Prizes

The prize giving ceremony will be organised after the Finals. Each driver of the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> places must be present on the Prize giving Ceremony dressed in racing dress.

### 17. Financial prizes

Financial prizes will not be payed, drivers will be awarded prices.

### 18. Prizes and cups

The Awards Ceremony will be organised after the Finals.

## VIII. ADDITIONAL INFORMATION

### 19. Fire Extinguishers

Each driver is responsible for ensuring that a single piece extinguisher of minimum 5 kg is available within his own team area inside the paddock.

### 20. .Protection of the Environment

Each driver is requested to ensure that a plastic sheet (minimum 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, et.

### 21. Driver Liaison Officer

Driver Liaison Officer will be reached in driver's paddock close to entranceto the track during all the championship. The Drivers' Liaison Officer will be recognisable by yellow vest and his picture will be posted on the Official Notice Board .

22. Each rider is allowed to use only one box. Only one service vehicle per competitor is allowed to enter the depot. Trailers and accompanying vehicles must be parked in a place designated for this purpose by the organizer (exception only if they fit in their designated box). When distributing the boxes, pay attention to the instructions of the authorized person of the organizer. Reservation of boxes (see picture) is only possible via e-mail [patriciadurcikova@outlook.sk](mailto:patriciadurcikova@outlook.sk) with the subject of the e-mail "reservation of boxes Mólča 2023". In the e-mail, it is necessary to state the number of boxes, the names of the drivers and the vehicles they will arrive on (van + trailer, bus, truck, etc.). The reservation will be evaluated, communicated back, possibly modified according to the current occupancy and subsequently approved.
