The Stewards, having become aware of the failure by the driver of car No. 58 to complete the FIA eLearning course for the FIA Safety Tracking Device within the prescribed deadline outlined in the Supplementary Regulations, summoned the above competitor's representative, have considered the following matter and determine the following:

**Facts** The Driver of car No. 58 did not complete the FIA eLearning course for the FIA Safety Tracking Device by the set deadline (21:00 hrs on Monday, 23<sup>rd</sup> October).

**Offence** Breach of Article 3.2 of the 2023 FIA WRC Sporting Regulations and Article 12.1 of the Supplementary Regulations.

**Decision**

- 1) Reprimand on the Driver of car No. 58 – EMERIC RARY
- 2) To set a new deadline to complete the FIA eLearning course for the FIA Safety Tracking Device by the Driver EMERIC RARY on Tuesday 24<sup>th</sup> October at 23.00 hrs at the latest.

**Reason** A hearing was held on Tuesday 24<sup>th</sup> October 2023 at 19.00 hrs in the presence of both crew's members as well as the Team Representative of Competitor No. 58, Mr. Damien Dulenc.  
The Driver explained that he had tried to complete the course and he had thought he had completed it.

The FIA e-Learning online course for the FIA Safety Tracking Device is an important and mandatory safety requirement for competing on WRC events.  
These courses are there for the safety of all competitors and the management of the special stages on the event.

The Stewards therefore concluded that driver of car No. 58 was in breach of the above regulations and that the penalty imposed is proportional to the infringement.  
Furthermore, as the above-mentioned FIA eLearning course is mandatory as prescribed in the Supplementary Regulations, a new deadline was set.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2023 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
