WAIVER OF LIABILITY

"Participant" also includes the registrant, if this should be a party other than the driver or co-driver himself.

The parties listed below accept <u>no liability</u> for any damages suffered by the participant in connection with participation in an event. <u>The relevant parties are:</u>

- the FIA;
- the KNAF and other (foreign) ASNs;
- the KNAF Talent First foundation;
- the organizer(s) and promotor(s) of an event or championship;
- · government agencies;
- parties otherwise involved in an event (such as timekeeping, rescue and ambulance service, et cetera);
- other event participants (including entrants, drivers, co-drivers, owners and/or keepers of participating vehicles, mechanics and helpers);

as well as the (section) boards, board members, management, staff, officials, clerks of the course and volunteers of all these parties.

Drivers declares that the owner of the car has given permission to participate with the car in this event. Also, the driver declares that the car used in the event is insured, as required by Law, and is valid for that part of the event taking place on public roads. Driver also declares that he is holder of a valid driver's license. In case the navigator has no valid driver's license and / or a valid rally driver license, he /she will not participate in the event as a driver and thus the driver and navigator declare not to change function."

If a member of the team is under 18 years of age, this Waiver of Liability shall also be countersigned by the legal representative, or a person authorized by the legal representative by submitting a written authorization of the ASN "Parent-child" license holder.
