The Stewards, having received a report from the FIA Technical Delegate (Document 6.28), having examined the photos included in the report, have considered the following matter, determine the following:

Fact: During routine checks at the finish of selective section 10, the technical staff noticed that a crew member (Frantisek Tomasek) of the vehicle No 501 had a camera fitted on the side of his helmet.

Offence: Breach of FIA International Sporting Code, Appendix L 2023, Chapter III, Art. 1.4

Decision: **To impose a fine of 1000 € to the crew member Frantisek Tomasek**

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason: The article Chapter III, Art. 1.4 of the Appendix L of the 2023 ISC states that *"No helmet shall be modified from its original specification as manufactured, except in compliance with instructions defined by the manufacturer. Accessories must be fitted in accordance with the helmet manufacturer instructions. Only accessories approved by the FIA shall be used. Any other modification or addition of non-approved accessories (helmet cameras, visors, etc.) will render the FIA helmet homologation void."*


In this case, due to the illegal modifications made to the helmet, the homologation of the helmet of a crew member is void. Stewards decide that the violation of the requirements set out in the regulations is beyond doubt and consider it appropriate to impose a fine penalty in this case

The decision is based on the FIA International Sporting Code Art. 11.9.1, Art. 11.9.3 f; Art. 12.3.1; Art. 12.4.1.c.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
