The Stewards having received a protest against the Provisional Classification of the Rallye du Chablais 2026, having summoned and heard from the Competitor and the Crew, and from the Clerk of the Course as a witness, have considered the following matter and determine the following:

Procedure:

1. On Saturday 30 May 2026, at 18:59 (GMT+01:00), the Clerk of the Course received from Sergio Fernandez Iglesias <sergiofernandeziglesias12@gmail.com> an email with the subject line "Protest of the decision about car H2" with the following text "We officially protest the result and based in your mistakes we want to be reinstated in the results".
2. The Stewards summoned (Summons Nr. 4) and heard from the Competitor's representative and from the Co-Driver.
3. The hearing was held on Saturday 30 May 2026 at 20:05 in the Stewards' Room with all the Stewards present,
4. No objections were raised against the composition of the panel of the Stewards.
5. At the hearing, the Competitor's representative and the Co-Driver stated that the email mentioned above was indeed their protest, and that they have not addressed any other protest in writing, and that they did not pay any deposit.

On the Admissibility:

6. The Stewards examined the admissibility of the protest.
7. The protest was lodged by a single Competitor, in accordance with Article 13.1 of the FIA International Sporting Code.
8. The subject of the protest was against the Provisional Classification of the Rallye du Chablais 2026, in accordance with Article 13.2 of the FIA International Sporting Code.
9. The protest against the Provisional Classification was filed in due time, in accordance with Article 13.3 of the FIA International Sporting Code.

10. The protest was not accompanied by a deposit, as requested by Article 13.4.2 of the FIA International Sporting Code and Article 65.2 of the 2026 FIA European Historic Rally Pre-2000 Championship Sporting Regulations.

11. Moreover, the protest did not specify the relevant regulations, as requested by Article 13.4.1 of the FIA International Sporting Code.

12. Having considered the matter extensively, the Stewards determined the protest is inadmissible.

Decision:

The protest filed by Competitor Daniel Alonso Villarón against the Provisional Classification of the Rallye du Chablais 2026, is inadmissible.

Competitors are reminded of their right of appeal in accordance with Article 15 of the FIA International Sporting Code and Chapter 5 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
