Minimum number of entries (80) has been reached.

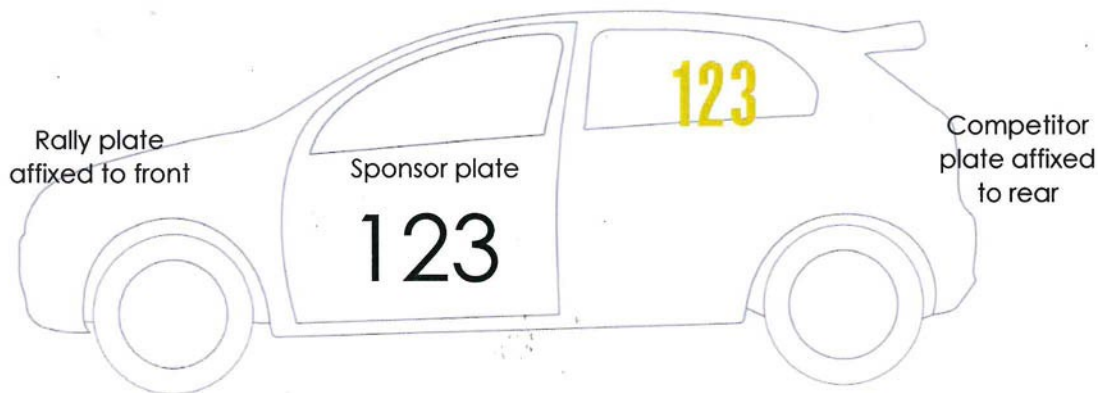

## Arrival Procedure

This year we are hosting Environmental Scrutineering and Trade Park (including tyre vans and fuel suppliers) at Mitchells Auction Mart, Map Ref: 89/115294 & W3W: [pedicure.pets.built](http://pedicure.pets.built). The Friday night Trailer Park is at The Memorial Gardens Car Park, Wakefield Road, Cockermouth which is Map Ref 89/117308 & W3W : [radically.ferrets.breathy](http://radically.ferrets.breathy). You can access this car park from noon on Friday 8<sup>th</sup> but you must leave by 10.00 on Saturday morning. NO TRAILERS are to be taken to M-Sport or Mitchells Auction.

Your trailer can be collected and taken to the service area at Penrith Farmers Auction , Penrith Map Ref 90/509289 and W3W: [ringside.replaying.smelter](http://ringside.replaying.smelter). Please park it where indicated by the marshal.

We have made no arrangements for overnight stays in whatever vehicle – you must sort out to sleep elsewhere!

Please note – you are responsible for the security of your trailer wherever you leave it.

Follow arrows/directions to collect numbers, rally plates, door headers and process cards and apply the stickers to the car before Environmental scrutineering. Don't block access as other businesses are operating.

### **Scrutineering & Documentation**

We once again have the pleasure of using M-Sport facilities for scrutineering, documentation & pre start and overnight parking for rally cars only. Map Ref: 89/097333 and W3W: blunt.rests.flick . DO NOT under any circumstances try to enter Dovenby village if you overshoot Dovenby Estate.

Please be super considerate of the local villagers and keep noise to a minimum on site.

**DO NOT REV YOUR ENGINES AT ANY TIME!**

This is really important if we are to return to M-Sport.

Scrutineering is at the rear of the MEC in one of the pit garages and documentation is next door – follow the directions.

There are a number of pages following which need to be completed by you prior to attending documentation. Delays are usually caused by not being ready! Championship Representatives will be on hand.

Whilst the organisers and M-Sport cannot accept any responsibility, competing cars are to be left where directed, overnight at M-Sport. You should make your own arrangements for your service vehicle.

No vans or trailers please. Access is limited to the competing crew plus service crew. Please be aware that certain areas of the site have restricted access, please confine your movements to the areas being used for the Rally formalities. There will be a burger van on site for hot food and drinks for both Friday and Saturday whilst the rally is present. Portaloos are available on site.

M-Sport is the home of the World Rally Team and our continued use relies on your behaviour i.e., keep off the grass and flowerbeds, no litter and no smoking except in designated areas. Extensive CCTV cameras monitor the area AND NO REVVING OF ENGINES!

### **Service & Trailer arrangements.**

#### **Friday 8<sup>th</sup>**

Trailers are to be left at the Memorial Gardens Car Park as above or your accommodation.

Friday night service is at Mitchells Auction Cockermouth. The restaurant inside the building will be open for food and drinks. Portaloos are provided.

#### **Saturday 9<sup>th</sup>**

On Saturday service crews should follow the route shown in the Assistance information to the Service Area in Penrith. Trailers can be parked behind your service slot but please follow the instructions of the marshals. Remember there are other users on site and the access road to the Highways depot

must be kept clear at all times. The restaurant is under renovation but there will be mobile catering units for hot food and drinks. Portaloos are sited in the service area.

## **Seeding**

## **Road Traffic Act**

Motorsport UK have asked us to remind you of the Road Traffic Act 1988 section 170 and Highway Code rule 286. This refers to your obligation to inform the Police of any accident causing third party injuries. The Stewards must also be informed which can be done through the organisers.
