Sportska komisija / The Stewards,

nakon što je primila prijavu od Direktora rally-a, razmotrili su sve dobivene informacije te odredili sljedeće / having received a report from Clerk of the Course, have considered the following matter and determine the following:

Činjenice/Facts: Nakon ulaska u parc ferme te predaje vremenskog kartona na VK8D SB75 je prijevremeno napustio parc ferme.
After entering parc fermé and delivering time card at TC8D Sno 75 made an early exit from parc fermé.

Prekršaj/Offence: Kršenje Članka 33.1.1. 2025 RRSR
Breach of Article 33.1.1 2025 FIA RRSR

Odluka/Decision: **Diskvalifikacija natjecatelj SB 75 Rino Muradore**
Disqualification of Competitor Sno75 Rino Muradore

Razlog/Reason: Nakon neuspješnog pokušaja saslušanja predstavnika posade telefonskim putem je saslušan vozač SB75 te je Sportska komisija donijela odluku o diskvalifikaciji natjecatelja SB 75 Rino Muradore. Kako je propisano čl. 33.1.1. 2025 RRSR-a nakon ciljne ceremonije vozila moraju parkirati u Parc ferme gdje moraju ostati do raspuštanja istog od strane Sportske komisije. Sportska komisija stoga zaključuje da je ovo kršenje čl. 33.1.1. 2025 RRSR.

After an unsuccessful attempt with team representative, hearing was held by phone with driver Sno75 that led to disqualification of SNo75. As stipulated in Art. 33.1.1 2025 FIA RRSR, after finish formalities, cars must be placed in a parc fermé where they must remain until released by the Stewards.. The Stewards therefore conclude that this is a breach of Art. 33.1.1 2025 FIA RRSR.

Posada se podsjeća kako ima pravo na apel na Odluku Sportske komisije u skladu sa čl. 15 2025 FIA International Sporting Code i poglavlja 4. FIA Judicial and Disciplinary Rules.
