REGISTRATIONS FOR SCHEDULED RACES

Entry close on **Friday July 10th 2026 at 12.00**

Registration must be made as follows:

Competitors with an Italian license: compulsory the on-line "pre-registration" procedure on the ACI Sport website (Information on how to use this procedure can be found on the ACI Sport website) Please note that pre-registration, once taken in charge by the organizer, will no longer be visible nor editable by the competitor.

N.B. A competitor with an Italian license may enter drivers with foreign licenses in the race.

The pre-registration, even if accepted, to be validated must be followed by sending the copy of the payment.

- **Compulsory** register on the "Circuit Enter" Website and upload the following documents:
- Competitor license and driver(s) license (front and back sides)
- Medical Certificate (if not included on the license itself)
- Scuola Federale qualification (if not included on the itself)
- In case of foreign driver - authorization ASN of membership (mandatory in case it is not shown on the license itself);
- Copy of payment of the event entry fee
- Copy of renewal of any expired documents (medical certificate and/or ACI association)
- Liability waiver
- In case of a minor driver, deed of assent of parental authority, and copies of the identity documents of the minor and parents.
- Clothing declaration

Competitors/ Drivers with foreign license: Compulsory send by email to ufficiosportivo@vallelunga.it the following documents (**Alfa Revival Cup e Copa Clio Espana excluding**):

- Competitor license and driver(s) license (front and back)
- Medical Fiche (if not included on the license itself)
- Authorization ASN of membership (mandatory in case it is not shown on the license itself);
- Copy of payment of the event entry fee
- Copy of renewal of any expired documents (medical certificate and/or ACI association)
- Liability waiver
- In case of underage (under 18) driver, deed of assent of parental authority, and copies of the identity documents of the minor and parents.
- Clothing declaration

In any case, an entry shall be considered valid and duly completed ONLY once the relevant entry fee has been paid.

All Competitors are reminded, when using the entry form, to provide all essential information (in particular licence number and technical passport number) and to attach the documents listed above in order for the entry to be considered valid.

NB: Only foreign competitors are required to submit duly completed and signed entry forms together with all the documents listed above.

The entry in any case is considered valid and finalized ONLY when the relevant entry fee is paid.

C) PIT BOXES

1) BOX RESERVATION

The allocation of garages (boxes) will be carried out by the Promoter, and the Organizer will subsequently send a confirmation notice together with a payment request.

2) COSTS

The cost for the entire Weekend (Friday, Saturday, and Sunday) of each box is as follows:

3) PAYMENT

Payments may only be made in advance by Bank Transfer immediately after receipt of the confirmation of allocation to the same bank details as for the payment of entries above.

4) KEY PICKUP AND RETURN

The garages (boxes) will be available from 18:00 on 16th July 2026.

The collection and return of the keys will take place at the main entrance of the Circuit.

5) SAFETY REGULATIONS INSIDE THE GARAGES (BOXES):

- Smoking, the use of open flames, and the storage of flammable materials (fuel, etc.) inside the garages (boxes) are strictly prohibited. Any flammable materials must be stored outdoors;
- Fire hydrants, fire extinguishers and all other fire-fighting equipment must remain clearly visible and readily accessible at all times;
- Emergency exits, passageways and escape routes must be kept fully accessible and free from any obstruction;
- Used oil must be disposed of in the designated containers located at various points throughout the Circuit;
- In the event of accidental spills of flammable liquids, oil or any substances that may make surfaces slippery, immediate action must be taken to remove the spill and clean the area.

6) GARAGE CLEANING

- We remind all participants that both the paddock areas and the garages (boxes) **must be left free of tires**, which must be removed and disposed of directly by the participants. In the event of non-compliance, the Circuit Management reserves the right to charge the offenders for the cost of disposal.
- The application of stickers, tape or adhesive materials of any kind to the garage (box) floors is strictly prohibited.
- Prior to returning the keys, all garages (boxes) must be cleared of any materials, equipment or items that were not present at the time of handover.

Please strictly observe these hours.

Transportation of materials and/or movement of heavy vehicles are not allowed during night hours unless specifically authorized by Circuit Management.

During the weekend, access to the main paddock for loading and unloading of materials will only be allowed for a maximum duration of 25 minutes with the issuance of a delivery pass (subject to a deposit of € 100.00).

3) SPORT CHECKS:

Competitors and drivers with italian licences, only and exclusively competitors/driver who are not in good standings with the documents sent with the registration or with documents that have expired in validity must present themselves.

Competitors and drivers with licenses issued by another ASN than ACI must compulsorily present themselves for the Sporting Checks (document verification and signing of the scrutineering form).

The Sporting Checks will take place on the 1st floor of the Race Control Tower, at the times specified in the Official Timetable.

4) TECHNICAL SCRUTINEERING

As per regulations, pre-race scrutineering will be conducted in attendance at the Scrutineering Garage or directly at the team's facilities. The forms required by the current regulations must be submitted at scrutineering in the prescribed places and manner. The forms can be downloaded [here](#).

ATTENTION:

The clothing declaration must be uploaded to the "Circuit Enter" portal and submitted in original during scrutineering.

5) EXIT OF TRUCKS AND DISMANTINGS

We would like to remind all participants that the dismantling of structures and the movement of vehicles may only take place - for safety reasons - at the end of the last scheduled race. Any failure to comply with this provision will be reported to the Stewards of the Meeting for the measures laid down in the Regulations.

E) EVENT LOGISTICS

1) PASS DISTRIBUTION FOR COMPETITORS AND SERVICES

With dedicated info bulletin you will receive the link to register your staff. The digital pass will be sent to you directly to the email address given during accreditation. To speed up the control procedures, we will deliver to each team, wristbands according to the number of passes requested. These wristbands can be picked up at the Accreditation Center.

G) SAFETY INFORMATION FOR PARTICIPANTS TO THE EVENT

WASTE DISPOSAL

It is absolutely forbidden to leave waste in the areas used by the Customer, including waste of a special nature such as, for example: tires, batteries, containers containing oil/fuel and vehicle parts in general, etc. Materials that the Customer intends to dispose of must be properly disposed of at his own care and expense.
