

ACCREDITATION REGULATIONS

It is possible to ask for accreditation for hillclimb race **Autopola Jankov vršok 2026** using the attached form on the website: www.jvrsok.sk

Please note media representatives who have all-year accreditation from SAMŠ or other ASN or FIA. They must also register for the event and take the card and vest PRESS from the organizer. In the case of non-accreditation, will not be covered by the provisions, rights and obligations relating to media representatives but will be taken only as a spectators.

Please send completed accreditation forms, if necessary, with the necessary attachments to email address: peter.belohorec@jvrsok.sk in original form . doc . Send accreditation forms unsigned, you will complete the signature at the place of accreditation.

Start of receipt of applications for accreditation is **15.7.2026**. The deadline for accreditation is given to **30.07.2026 at 23:59**.

After this deadline is not possible to apply for accreditation. After receiving accreditation form, you will be informed by e-mail message about the acceptance or rejection. The granting and refusal of accreditation is the exclusive responsibility of the organizer of event.

Notice: ASN SAMŠ is the owner of all television and broadcast rights related to the organization of championships/events advertised by SAMŠ, unless otherwise agreed. The only exceptions are those for which international organizations (FIA, FIA/CIK) have reserved television and broadcast rights. All transmissions and broadcasting from them can only be carried out by the agency/TV to which SAMŠ has assigned the broadcasting rights.

A – PRESS

In order to accept the accreditation, media must be given in public circulation and be available to the public (sales). **Publications of autoclubs and companies (competitors) with internal circulation and advertising agencies cannot be accredited as media!**

Simultaneously with the application for accreditation, it is necessary to submit the documents as mentioned below; it is inseparable part of the application for accreditation. Without these documents accreditation will not be accepted!

1. Completely fulfilled accreditation form (separately for each individual applicant for accreditation).
2. Copy of the press card (international press license national press license,...) or accreditation license of ASN-SAMŠ, FIA a particular applicant for accreditation.
3. Information about publication (frequency range, regional circulation, etc.).

We request that press representatives send us within one week, to the address

peter.belohorec@jvrsok.sk a link to the website or a copy of the periodical where the report on the event appeared. The report must mention the event's official name, "Autopola Jankov vršok 2026," and include the event's logo.

Accreditation of journalist is subject to duty wearing tags marked PRESS in a visible place and the safety vest of journalist, borrowed from the organizers for a financial deposit € 20,- (twenty euro), with a visible mark PRESS and number of journalist accreditation. Own safety vests are not accepted. Please wear the vest and the badge throughout the entire event (not in a pocket or hanging from a backpack).

B - RADIO, TELEVISION, VIDEO, PHOTO AND ELECTRONIC MEDIA

Granting accreditation to radio, television, video studios and other electronic media (Internet) are fully in competency of the organizer. Simultaneously with the application form for accreditation must be submitted following the appendixes. Without them application will not be accepted.

1. Completely filled accreditation form (separately for each person applying for accreditation).
2. Copy of the press card (international press license, national press license...) or accreditation license of ASN-SAMŠ, FIA a particular applicant for accreditation.
3. Brief description of the media company (frequency, activities, scope etc.).

Accreditation TV / PHOTO is subject to duty wearing tags marked PRESS in a visible place and safety vest borrowed from the organizers for a financial deposit € 20,- (twenty euro) with a visible mark PRESS and number of journalist accreditation. Own safety vests are not accepted. Please wear the vest and the badge throughout the entire event (not in a pocket or hanging from a backpack).

Private (commercial) video study and website's based on agreement with the organizers places the logo **Autopola Jankov Vřšok 2026** and logo **SAMŠ** (ASN) into their records. There is a condition to supply for free until 1 week after the event 2 pieces of DVD records or web address of video to the organizer in Full HD quality or higher. We ask media representatives, until 1 week to address **peter.belohorec@jvrsok.sk**, posted an internet link or journal, which published a report of the event. We ask photographers to send at least 10 or more photos in electronic form from the event within 1 week, or a link where they can be downloaded. Internet portals are obliged to attach the official logo of hillclimb events into their reports.

All accredited media representatives must be older than 18 years and be eligible for law acts. (They could be requested to demonstrate that during the accreditation). Tags and vests will be available for collection at the race headquarters from **July 31, 2026 from 5:00 PM to 7:00 PM and on other days, if possible, from 7:00 AM until the end of the race on that day**. Each accredited journalist must register at the press center and sign the accreditation form in person. By signing, they confirm that they are familiar with the accreditation rules and will comply with the obligations arising from them. This obligation cannot be delegated to a third party!

Movement of the accredited media representatives in race areas

There are no special places created for the media. However, they can enter places where they are not allowed for spectator. Instead, the place must be not dangerous and must have permission from the organizer or track marshal.

- during the interruption of the race, the representative of the media may walk on the closed track with the permission of the organizer or the track marshal. They must be not obstruct work of the organizers and must take care of security.
- Unlimited in the service park
- Unlimited in designated areas on the race track
- Unlimited in prestart area

Places marked as "**Forbidden area**" on the race track are also **forbidden** for all accredited media representatives.

Disobeying command of marshals may result in:

1. stopping the race
2. announcement for the Clerk of the Course
3. withdrawal of accreditation and in a very rude behavior reporting an SAMŠ-ASN and domestic ASN or FIA

Movement of the media representatives with vehicles on the track or service park is **prohibited** in the time of the race; only director of the race can authorize to move also on the track.

ATTENTION! In general, there is a forbidden the use of drones. Exceptions are not granted.

The cameras without operator is allowed only off the track. The organizer or the driver assumes any liability for damage with the race car, in an accident with camera.

Using selfie poles are permitted. The far end of the pole not exceeding the barrier. Where the barrier is not as far as the roadway boundary.

Placing of the advertisements in the race areas is **prohibited**.
