The Stewards, having received a report from the FIA Technical Delegate, summoned a representative of the above competitor, have considered the following matter and determine the following

Facts During SS19 RIUDECANYES 2, 0.09kJ hybrid boost on car No. 6 was used without valid

regen

Offence Breach of Article 3 of Appendix XV (Rally 1 – Hybrid Strategy – Details) of the 2022 FIA

WRC Sporting Regulations, in conjunction with Article 11.9 of the Supplementary

Regulations.

Decision 5-second time penalty to be applied to the time recorded by Competitor No. 6 on SS19,

in accordance with Article 12.4.1.h and Article 12.4.2 of the 2022 FIA International

Sporting Code.

Reason The Stewards studied the report from the FIA Technical Delegate and heard from the

Team Manager Mr. PABLO MARCOS of the Competitor HYUNDAI SHELL MOBIS

WORLD RALLY TEAM on Sunday 23rd October /2022 at 17.38 hrs.

The representative of the Competitor explained that after the start launch of SS19 the car boosted 0.08kJ without a valid regen, which is due to latency in the communication system and exceptionally hard braking. As this problem had never occurred before (also not while testing), the team did not have any idea that this could happen. The Team

Manager stated that this mistake is possible to avoid in the future.

The Stewards considered that, although the performance advantage was negligible, the minimum regen 30kJ value was not met in order to have an extra boost. They therefore decided to impose the above penalty, also considering that it is the competitor's responsibility to ensure compliance of the car at all times. As the breach of regulations occurred on SS19 RIUDECANYES 2, which was also the Power Stage, the Stewards decide to apply the penalty to the stage time recorded by Competitor No. 6 on SS19, as per 2022 FIA WRC Sporting Regulations Art. 50.4.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2022 FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules.
