The Stewards have received a petition from Toyota Gazoo Racing for them to review, in accordance with Article 14.1.1 of the FIA International Sporting Code. Following the Stewards Decision N° 1 they having investigated GPS data and have heard the Clerk of the Course and the representative of the ERTF, determine the following:

**Decision:** The Stewards amend the Final Classification of the Qualifying stage and require Clerk of the Course to delete the application of 10-second time penalty of car # 223 (Document 3.12).

**Reason:** Following the Stewards Decision N° 1 they have investigated GPS data and have heard the Clerk of the Course and the representative of the ERTF as GPS provider of the Event. During the hearing, the provider stated that they had technical difficulties setting up their system based on the structure of the Qualifying Stage. Following the beginning of the Speed Control Zone (Roadbook 1A, sign 11, DZ) the next roadbook sign was 60 metres distance only, so they needed to change the radius of the tolerance zone of the DZ sign to 75 metres in their system instead of 90 metres as it is regulated by 37.1.3 of FIA CCSR 2022.

After investigation of the GPS data, the Stewards found not only one but three cases when the place of the speed infringement was within the 90 meters tolerance zone. With the power given by the FIA International Sporting Code (article 11.9.3.j) and the Decision of the Stewards (Document 2.3) to review the Final Classification of the Qualifying Stage (with applied time penalties), the Stewards took their decision above.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
