Reason(s) for this decision:

EVIDENCE PRESENTED BY J.O.F. IS THAT THE SPEED OF RED FORD FIESTA HFT8 EBU ON NIGHT OF TUE 08-OCT WAS 'EXCESSIVE', HOWEVER, COULD NOT VERIFY >40MPH. JOF ASSERTION IS THAT, FURTHER, NO RECONNAISSANCE PLATES WERE IN POSITION, FROM PHOTOGRAPH OF RECCE CAR PARKED 23.11, RECCE STICKERS CANNOT BE CLEARLY SEEN, HOWEVER TAPE IS NOTED IN REAR WINDOWS. FOLLOWING CROSS-EXAMINATION AND FURTHER PICTURES SUPPLIED BY COMPETITOR, IT IS DEEMED THAT TINTED REAR WINDOWS HAVE HAMPERED THE DISPLAY OF RECCE STICKERS, AND THAT ON THIS OCCASION OWING TO THIS AMBIGUITY THERE IS INSUFFICIENT EVIDENCE UPON WHICH TO DEFINITELY ACT.
