The Stewards, having received a report from TD (document No 6.1), having examined, summoned and heard the driver **PUTYS JUSTINAS** and co-driver **Milasevskis Waldemaras** (summons No 4.1), have considered the following matter, determine the following:

- Driver and car No:** Putys Justinas, #608
Competitor: Putys Justinas
Session: Scrutineering
Fact: Not valid vehicle registration papers (document confirming the admission to road traffic) of entered competing vehicle.
Offence: Breach of Article of the 1.1 of Appendix 3 of Polish Cross-Country Rally Championship Regulations and Article 9.1 and 10.2 of Columna Medica Baja Poland Supplementary Regulations.
Decision: **Disqualification**
Reason: Having considered the matter extensively, the Stewards determined that the Competitor did not file the required papers as indicated in article 9.1 and 10.2 of Columna Medica Baja Poland Supplementary Regulations, i.e. valid vehicle registration papers (document confirming the admission to road traffic) during Administrative Check and Scrutineering.

During Scrutineering the Competitor submitted non-valid Polish vehicle registration papers.

After having examined the Competitor and the co – driver the Stewards, during the examination, received the photo of service plates and service book for these plates as registered in Hungary, because their Polish vehicle registration papers are not valid. The Competitor admitted that they want to use them during this rally. Also the Stewards received a Lithuanian technical examination paper where the comply with requirement are stated and Hungarian service plates were issued on this certificate (that was different plate number than in entry form and scrutineering).

Moreover, there were presented three numbers of car policies: one for service plates, second for the rally car VIN and third different number in technical examination papers. Only two first policies documents were presented.

After free translation of Hungarian papers, there were indicated that those service plates can be used for the cars that are allowed to the road traffic and in special circumstances. There was no information about allowance to start in rallies.

Besides of all above facts and after analyses all papers and information from Competitor it cannot be stated with certainty that the car meets the conditions for admission to these competitions. Therefore, Stewards decides as above.
