#### 4.6. Refunds

The entry fee will be refunded in full to candidates whose entry has not been accepted.

##### **Refund in case of a withdrawal:**

A written declaration of withdrawal of the crew must be sent by email to the organiser ([invoice@ypresrally.com](mailto:invoice@ypresrally.com)) before 20/06/2024.

This declaration must contain the following:

- The reason for withdrawal
- All necessary data for reimbursement

A receipt will be sent to one of the team members as confirmation.

If the withdrawal is submitted before 01/06/2024 at 12h00, a full refund of the total entry fee will be made within a maximum of 90 days after the end of the competition.

If the team's declaration of withdrawal is submitted after 17/06/2024 at 12h00, a refund of 50% of the entry fee will be made by the organiser within a maximum period of 90 days after the end of the competition.

##### **Refund of the entry fee in case of annulation of the rally by Force Majeure:**

The organisers have taken out a Motor Vehicle Civil Liability policy - according to Art 21 of SR BRC 2024 chapter 2/2 of the National Sporting Code and the law of 21 November 1989 - Art 8, which covers damages to third parties by the nominative competitors and teams listed (on the official list of competitors) and this only during the Shakedown, and participation within the time schedule on the rally route, from the start of the first competition element until the end of the rally or at the time of permanent abandonment or exclusion.

### 5.1. Civil liability “Car”

#### Insurance cover limits:

- bodily injury: unlimited per claim
- material damage: 100,000,000 € per claim (indexed)

All cars participating in the rally must have insurance valid for public roads. A valid green card (International Motor Insurance Card / Carte Internationale d'Assurance Automobile) or other certificate proving that the insurance policy to which this certificate relates meets the requirements of the relevant legislation applicable in Belgium and France and serving as proof that the car is validly insured. This document must be presented during the administrative checks.

Road sections are not covered by the organiser's BA insurance contracts.

'Service', 'Auxiliary' and reconnaissance vehicles, even if they carry the special rally plates, issued by the organiser, are not covered by the organiser's civil liability insurance policy

### 5.2. Civil liability “Organiser”

The organisers have taken out Civil Liability Insurance for damages to third parties caused by an accident during the preparation, conduct and material conclusion of the event and attributable to organisational error.

#### Insurance cover limits:

- physical, material, and immaterial consequential damage mixed: 5,000,000 € per claim.
  - exemption: 125 € per material damage claim
- Legal assistance:** 15,000 € per claim

#### Insured parties:

Organiser, RACB, Official, National Sports Commission, Members of the Red Cross or similar Organisation, Members of Civil Protection, Participants, Marshals, the drivers of the Intervention cars, and in general, any person participating in the organisation of the rally.

### 5.3. Civil liability “Volunteers”

Civil liability of organisers for damage caused to third parties by volunteers he calls on, during their volunteer activities.

#### Insurance cover limits:

- physical damage: 12,394,676.24 € per claim (indexed)
- material damage: 619,733.81 € per claim (indexed)

### 5.4. Conduct by an accident (National Road Traffic Regulations)

- In the event of an accident with only material damage, drivers are obliged to make a verbal declaration to the next time control and a written declaration with a detailed report before the end of the 'Stage' to the clerk of the course (reporting officer). Failure to make a declaration will be penalised by a €500 fine. In case of an accident with physical damage, the drivers must immediately inform the competent police services and the Rally Control at the Rally HQ via the phone number indicated on the back of the time cards. (Art. 53.3.8)

- In case of an accident in which a spectator, or any other person, suffers physical injury, the (co-)driver must stay on the spot and stop the next car to let them report this to the next radio post, as mentioned in the road book and indicated along the route. (Art. 53.4)
- The law of the country, where the competition takes place, must be applied in relation to procedures to be followed in case of an accident. Under Belgian law, hit-and-run is a correctional offence. All competitors stopped in such procedure will be given a notional time in accordance with Art 52 SR BRC 2024.
- The safety regulations in case of accident by a competitor will be included in the road book.

## 5.5. Recovery of the car

For safety reasons, the Organiser may decide to recover a car that has not completed the special stage in order to no longer hinder the special stage.

## 5.6. Waiver of recourse

The Organiser disclaims all liability related to the consequences of violations, committed by drivers or participants, of the laws, regulations, and decrees applicable to the crossed lands. The consequences will be borne by the offenders themselves.

The Organiser also declines all responsibility in the event of natural disasters, demonstrations, riots, attacks, sabotage, and terrorism, etc of which the participants, drivers, team members or occupants of a vehicle could be victims and whose consequences (material, criminal and sporting) will have to be borne by themselves.

## 6. Publicity and Identification

The organiser will provide each crew with the competition numbers (67x17cm), which must be affixed to their car in the specified places prior to the technical scrutineering. Each panel must be placed horizontally at the front of each front door, with the number at the front. The top of the panel must be between 7 cm and 10 cm below the lower limit of the window. **The panel cannot be cut.**

### 6.2. Optional organiser’s advertising

**Extra advertising of the organiser:**

- sticker (10 x 30 cm): Ardeca

### 6.3. Identification

- Competition numbers and rally plates according to SR RACB Art. 27 and 29 will be issued by the Organiser.
- Numbers and plates must be affixed to the rally car before the car is brought to the technical scrutineering and must remain visible throughout the rally.
- Deviations from the regulations on rally plates and identification numbers will be penalised as follows:
  - one missing rally plate or competition number: fine of 100 €.
  - simultaneous missing rally plates or competition numbers: disqualification
  - rally plate invisible or number plate partly covered: fine of 100 €
  - absence of optional publicity by the Organiser: payment of entry fee without publicity

#### 6.3.1 Team service vehicles

Service / Auxiliary car passes (stickers) and other car passes (identification stickers) must be affixed in the upper right corner of the windshield (on the passenger's side - on the inside).

## 7. Tyres

### 7.1. Regulations regarding tyres which may be during the rally

See Art. 13 RS BRC.

Cars in classes RC2-RC3-RC4-RC5 must compulsorily use MICHELIN tyres from the distributor designated by RACB Sport.

### 7.2. Tyres to use during reconnaissance

Only commercial tyres approved for road (asphalt) use are allowed.

### 7.3 Quantity of tyres

The maximum number of tyres permitted for this rally (in accordance with Article 13.1.5 of SR BRC):

- for the cars in classes RC1, RC2, RGT, RC3: 14 tyres
- for the cars in classes RC4 or RC5: 10 tyres

Article 19.4 of the RS BRC 2024 regulations - tyre control card 'tyre card' will apply to all the cars concerned. Tyre cards will be distributed at the technical scrutineering.

The list of eligible asphalt tyres is available on the FIA website.

- During the Qualifying Stage, the tyres will be marked and count for the allocated tyres.
- During the Shakedown, tyres are not marked and will not count for the allocated tyres.

## 8. Fuel

### 8.1. Types of fuel

All competitors must use fuel in accordance with Art 62.1 du RS BRC as approved by the suppliers of the Belgian Rally Championship 2024.

8.1.1 The specifications of fuels and RACB Sport designated suppliers are available in Appendix 6 RS BRC.

### 8.2. Order procedure

8.2.1 Competitors must place their orders at the latest at the closure of entries and do so with the suppliers at the address listed below:

#### 9.1.1 Reconnaissance registration form

If a competitor's reconnaissance car needs to be replaced for any reason, the competitor must inform the clerk of the course and provide details of the replacement car. The reconnaissance sticker must be placed on the replacement car.

## 9.2. Specific rules

During the reconnaissance, all national traffic regulations must be followed, including but not limited to speed limits. Please note that special stages are not closed to public traffic during reconnaissance. The organiser may separately reduce the permitted speed limit by marking areas in the Road Book and along the route.

Excessive speed during reconnaissance will result in a time penalty imposed by the Clerk of the Course according to Art. 34.2 RS BRC.

### 9.2.1 Passages

All crews may do up to 3 reconnaissance rides over each special stage, and in accordance with the reconnaissance programme given in Appendix 2. All reconnaissance of the rally route must be driven in the same direction as the rally, at a moderate speed and in strict compliance with the national traffic regulations. Special stages driven twice are considered as one stage during reconnaissance.

Teams are only allowed to enter and exit the special stages through the start and finish checks. Furthermore, random checks may also be held on the special stages.

#### 11.1.1 Technical scrutineering, mandatory documents

- SOS / OK card (DIN A3 format)

### 11.2. Safety equipment of the Driver and Co-driver

All clothing including helmets and FHR (Front Head Restraint) intended to be used, e.g. HANS devices must be presented for technical inspection. They should be checked for compliance with Annex L, paragraph III.

### 11.3. Noise level

For all cars, the maximum noise level is 95 dB on the road sections. Cars not complying with this rule will not be allowed to start. The noise will be measured with a sonometer regulated 'A' and 'SLOW', at the angle of 45 degrees and 50 cm from the exhaust, at a speed of 3 500 rpm.

### 11.4. Special national requirements

- Belgian-registered cars need a certificate from the A.K. (Automobiel Keuring/Contrôle Technique);
- Each car must be equipped with a red reflective triangle, safety vests and a first-aid kit in accordance with EU traffic regulations;
- There must be two seat belt cutters on board at all times, easily accessible to the pilot and co-pilot with the seat belts fastened.

### 11.5. Installation of the Safety Tracking System (STS)

#### 11.5.1 Collection

All cars must be equipped with a Safety Tracking System supplied by the service provider 4Rally. The STS devices will be handed out during the distribution of material and documents. The procedure and technical supplies will be explained in an additive. Competitors whose installation has not been done properly must put it in order before the start of the rally.

Any damage, loss or in case of theft, remains under the full responsibility of the team, even in case of retirement, disqualification, or any other course incident.

#### 11.5.2 Return

The organiser will dismantle the complete STS device in the Parc Fermé End of Rally.

In case of earlier retirement, the competitor can return the STS device to the Rally HQ (Vleeshuis, Neermarkt 9, Ypres) during opening hours the HQ.

## Shakedown

- Due to space limitations, trailers are not allowed in the Service Park of the Qualifying stage and the Shakedown. Lorries longer than 10m may not leave the Service Park of the Qualifying stage and Shakedown before 23h00.

## 12.3. Start procedure and order

There will be a ceremonial start.

The start of the rally will take place on 21/06/2024 at 15h05, from TC0 Ceremonial Start.

Starting order and intervals throughout the event will be in accordance with Art 41.5 SR BRC. The time interval will be 1 minute for all competitors.

The start times will be published on 21/06/2024 at 10am on ONB and DNB.

### 12.3.1 Start area

The Start Park is considered as Media Zone. Service is not allowed in the Start Area.

## 12.4. Arrival procedure

After TC 18B (Technical Zone OUT), all crews will be under the Parc Fermé rules and will have to follow the instructions of the on-site officials to get to the Finish Podium. This area will only be accessible to officials with the appropriate pass.

After the Finish Podium ceremony, cars will make their way, following the road book, to the waiting area of the Parc Fermé under the supervision of the Organiser.

Selected rally cars are escorted to the final scrutineering and/or will proceed to the final Parc Fermé. The Parc Fermé regime will be controlled by the Organisers.

### 12.6.1 Contact details of the crew

Competitors who park their vehicles in the Parc Fermé after crossing the finish line must remain available by telephone (mobile) until the final classification has been published.

### 12.6.2 Classification

The final classification will not be handed out after the rally. The final classification will be published on the DNB of the website.

### 12.6.3 Safety of the competitors

All participants are reminded to pay special attention to Art. 53 SR BRC.

#### Crew contact details

All crews will have to provide a mobile phone number during the administrative checks. This phone will be on board of the rally car at all times throughout the rally and will also remain connected within 30 seconds of the car stopping on a special stage. This rule is part of the team safety procedures in the Special Stage Safety Plan.

A TEAM (service) mobile number must also be submitted

### 12.6.4 Other points

#### Gravel Crews

- “Gravel Crews” are allowed for Rally2 and RGT competitors;
- Last entry time for gravel crews is 70 min before the 1<sup>st</sup> competing car;
- The registration form for the ‘Gravel crews will be available at the DNB. This form must be sent, fully completed, by email [macarena.delsante@ypresrally.com](mailto:macarena.delsante@ypresrally.com) at the latest on 12/06/2024.
- All national traffic rules must be respected on the special stages and on the road sections between the special stages. The maximum speed on special stages is 70 km/h. Crews of Gravel crews must drive carefully at reduced speed, in the same direction as the rally. Any violation of these provisions will result in the immediate withdrawal of the specific identification issued by the Organiser and will be reported immediately to the Stewards.
- Identification numbers issued during the distribution of materials and documents must be affixed to the car (upper right corner of the windscreen) and must remain visible during the rally.

#### Tyre warming

In order to ensure the safety of the public, it is forbidden, while entering a special stage, to warm up tyres or brakes. It is also forbidden, on public access roads, to proceed to start with an irresponsible driving style (zigzagging, etc.). Tyre Warming Zones (TWZ) are provided for each special stage.

Any infringement will be reported immediately to the Stewards.

#### Speed infringements

“Judges of Facts” (ISC Art 11.16) will be appointed to monitor compliance with all regulations relating to the Service Rules and Service Parks. Special attention will be given to compliance with the speed limit (30 km/h) in the Service Park and 5 km/h in the Fuel Supply Zone. (Art. 61.2).

Any infringement will be reported immediately to the Stewards.

#### Service Park

All teams must have a 6 kg fire extinguisher visibly available at their service area during the entire scheduled service time of the car.

The use of a ground sheet is mandatory.

No fuel of any kind may be stored in the service park, in service cars and/or assistance vehicles. Confiscation of fuel will be accompanied by a €500 fine imposed by the Clerk of the Course. It is absolutely forbidden for a car carrying fuel to have access to the service park and/or drive in it. Only a maximum quantity of 20 l of fuel necessary to fill the tanks for the equipment (generator, heating, etc) will be allowed.

#### **On-board cameras**

- If requested by the Organiser, a competitor must accept an on-board camera or other recording device on board. This will be placed by the Organiser and inspected by the technical delegates.
- The competitor of each car placing an on-board camera must obtain prior permission from the Organiser. Authorised cameras will be identified by a sticker and must be fitted in the car before the technical scrutineering.

Image recordings and/or data cards from on-board cameras may be exchanged in the service cars, with the approval of the clerk of the course.

#### **Media zones**

An enclosed media zone will be set up in front of the Service Park. Access to these media zones will be restricted to those with appropriate pass.

#### **Car collection from Parc Fermé at end of the rally**

After the permission of the Stewards to open the Parc Fermé End of Rally, the cars can be collected, provided that the release is on schedule and all cars must be removed before 23/06/2024 at 00h00.

To collect their cars, the drivers, or their legal representative, must present the 'Release Permit' issued by the Organisers to the person in charge of the Parc Fermé. This document will be given to the competitors when they enter with their car the Parc Fermé at the end of the rally.

All protests and/or appeals must be made in accordance with Articles 13 and 15 of the Code and, where applicable, the FIA Legal and Disciplinary Rules.

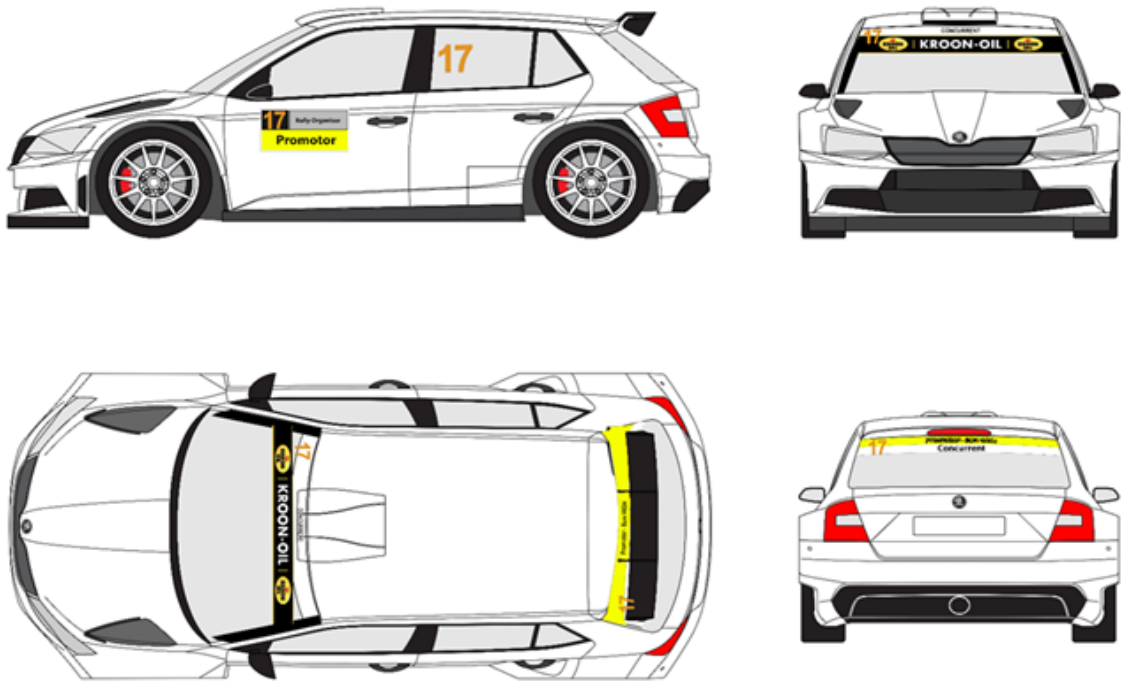


## Appendix 4 – Stickers and obligatory advertising

## Appendix 6 – Qualifying Stage

### B6.1 General

A Qualifying Stage will be organised for all FIA Priority drivers and Gold entries to determine the starting order of the rally until at least the first regrouping after a 45-minute service, always subject to RACB SR Art. 41.1.

#### B6.1.1 The Qualifying must:

- be run on a special stage with three Qualifying sessions (QR1 - QR3)
- form part of the rally itinerary, but not part of the rally results
- be representative of the rally

B6.1.2 During Qualifying, the entered driver must drive the car.

### B6.2 Running of the Qualifying

#### B6.2.1 Start order

The starting order remains unchanged during the three sessions.

### **B6.2.2 The Qualifying has three sessions:**

- a) For the first session (QR1), all eligible competitors will contest QR1 and at the end of this QR, the fastest 15 competitors will be allowed to start the second session.
- b) After a break of at least five (5) minutes, Qualifying will resume, and the fifteen (15) remaining competitors will start the next session (QR2). At the end of this session, the slowest five (5) competitors will be excluded from further participation in Qualifying.
- c) After a break of at least five (5) minutes, the final session (QR3) will resume, and the ten (10) remaining competitors will be admitted to the QR.

**B6.2.3** At the end of Qualifying, the times of each competitor will be officially published (Classification of Qualifying). In case of a dead heat after QR3, the competitor who sets the best time on QR1 will be ranked higher. If this is not sufficient, the time of QR2 will be considered. In the event of a dead heat in QR1 or QR2, and the time qualifies for the next run, both teams may continue in the next run.

**B6.2.4** Each result will be calculated based on the time of the session plus any other time penalty incurred in this session, including any false start penalty time.

### **B6.3 Non-participation or withdrawal during Qualifying**

**B6.3.1** Any car that breaks down during Qualifying or during the following road section will not be allowed to continue Qualifying and will be brought to the Parc Fermé by the organisers as soon as Qualifying is completed.

**B6.3.2** Any driver not participating or not completing the Qualifying correctly will be classified last in the session. If more than one pilot does not complete the session, the standings will follow the order of the starting list for the Qualifying stage.

### **B6.4 Interruption of a Qualifying run**

**B6.4.1** If QR1 is interrupted or stopped for any reason, any crew concerned may restart in QR2. The time achieved will be allocated as notional time for QR1.

**B6.4.2** When a QR2 or QR3 is interrupted or stopped for any reason, each crew concerned will be allocated the time achieved in the previous run.

**B6.4.3** No crew solely or jointly responsible for stopping a leg can benefit from this measure.

### **B6.5 Early or late check in**

Any late or early check-in at time control prior to the start of a Qualifying (TCQ1-TCQ3) will be considered an incorrect entry and Art. 37.4.2 of the FIA Regional Rally Sporting Regulations will apply.

### **B6.6 Regroup/Service**

**B6.6.1** Before each Qualifying session, there will be a regrouping according to Article 46 of these regulations. Any work within the regroup may only be carried out by the crew alone, but only with the equipment on board.

**B6.6.2** The individual start time of each competitor at the time of TC Regroup OUT will be published on this TC and on the DNB.

### **B6.7 Parc Fermé after Qualifying**

All cars taking part in Qualifying or dropping out in any session must be taken immediately and directly to the Parc Fermé designated by the organiser and remain there until they are released by the Stewards.

### **B6.8 Attributions of start positions (Start order)**

The starting order for the rally is as follows based on the Qualifying standings:

- The top 10 from Qualifying (QR3)
- The next 11th-15th from the Qualifying (QR2)
- The remaining competitors from the Qualifying (QR1)
- All other competitors at the discretion of the organiser

## Annex 7 – Service Park

### Dimensions

Each competitor is entitled to 8 metres of frontage.

If a team provides assistance for several cars, they will each get 5 metres extra per vehicle (ie: 13 for 2 cars, 18 metres for 3 cars, ...).

### Location

The Organiser will limit and number the service areas.

### Access to the service park

Reminder: cars with " AUXILIARY " car passes are not allowed in the service park and must be parked in the places reserved for them.

### Cleanliness/waste

Waste bins and containers will be available in the service park and must be used.

It is forbidden to throw tyres and glass into these containers.

### Fire prevention

In connection with the provisions of the municipal regulations and fire regulations:

- It is forbidden to use heating and/or cooking appliances with "open flame". This means " camping gas, barbecues, ...ed. "
- Is the use of gas cylinders are prohibited.

### Music installations

The Organiser is at no time responsible for the private use of music installations in the service park.

Each participant must comply with the applicable Belgian regulations (SABAM, fair remuneration, etc.) for the distribution of music in public places.

### Electricity

The Organiser will not provide any electrical installation in the service park unless requested in advance from the organiser.
