The Stewards, having received a report from the Clerk of the Course with video evidence attached, summoned the above crew members as well as a competitor's representative, have considered the following matter and determine the following:

Facts On Sunday 24th May 2026, Car No.56 performed a dangerous manoeuvre (weaving) on the road section between TC8E and TC9 in the village Sutterudhojden.

Offence Breach of Art. 3.4.2 of the 2026 FIA International Sporting Code

Decision Fine of 350 euros on the Driver of Car No.56 Sebastian DALLAPICCOLA

In accordance with Article 12.8 of FIA International Sporting Code the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>
Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason The Competitor, as well as the crew members, were informed accordingly by the Stewards and were given the possibility, if they wished, to bring forward any representation.
A hearing was held on 24th May 2026 at 11:02, attended by the Team Manager of Car No. 56, Mr Alessandro BALDON, who admitted the mistake and apologised for the crew's driving behaviour.
The Stewards examined the video evidence available, which shows Car No. 56 weaving on the road section between TC8E and TC9 in the village Sutterudhojden. The Stewards, after due deliberation, conclude that the driver of Car No. 56 was in breach of art. 3.4.2 of the 2026 FIA International Sporting Code, which explicitly mandates that the crew must observe the national traffic laws, and this was reminded to all Competitors by the Clerk of the Course during the drivers' briefing. They, therefore, imposed the above fine under art. 34.3.4 a) of the 2026 FIA Regional Rally Sporting Regulations.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the 2026 FIA International Sporting Code and Chapter 5 of the 2026 FIA Judicial and Disciplinary Rules.
