

# **STPR 2025 Recce**

1. The State Speed Limit in the forest is **25 mph** and posted on most Forestry Notice Boards (see picture below)



2. The posted speed limit on Waste Management property is 10 mph. They have agreed to raise it to 20 mph for rally traffic. Please be respectful of their generosity.
3. Traffic (both rally and public) will be travelling in both directions on the roads; **expect to encounter oncoming traffic at any time.**
4. Waste Management stages will only be available during the time below as stated in the schedule and will have a stage speed limit of 30mph.
  - Thursday – (Stage 3 & 7) 17:00 (5PM) – 18:30 (6:30PM)
5. Reconnaissance is open from 06:00 (6AM) to 6PM on Thursday, 7/10 for all stages except WM (Waste Management noted above). You must be out of the State Forest by the end time of day.
6. Competition starts at registration prior to Recce and ends at awards.
7. STPR will have “O” Controls active during Recce. “O” controls will relocate throughout the day at random times. DCNR will also be patrolling the area.
8. Penalties are per the 2025 ARA Rally Competition Rules, partially copied here:

## 1.2.1 h) Infractions

Violation of RCR 1.2.1 will be penalized as follows:

- 1) First infraction within an event: \$200
  - 2) Second infraction within an event: \$400 plus the first \$200 and loss of 5 points overall and loss of 5 points in each championship category the competitor is eligible for
  - 3) Third infraction within an event: Exclusion from the rally plus the \$600 in fines and loss of points already accrued as well as forfeiture of all entry fees paid
- Any infringements of the other Reconnaissance regulations, reckless driving, or excessive speeding will be reported, by the organizers, to the Steward(s) who may impose penalties as per GCR 7.4.

9. Any penalty must be paid prior to entering the Friday MTC prior to Stage 2 at the Galetton Parc Expose. An event official will be at the MTC to collect any fines if necessary.
10. GPS coordinates for all ATCs and FTCs are included at the back of this package.
11. Food and Gas is not readily available in the area of the forest stages. Always have a full tank of gas when you travel into the forest stages. Plan accordingly.

Summary: The competitors can cover the stages in the following sequence. This is the suggested route that will limit backtracking and additional transit miles.

- Note, the WM (Waste Management) stage can be Recced during the times listed on the front sheet of the Recce Routes and the Supplemental regulations.


1. Transit to Patterson Hungry I
2. Stage 2/6 (Patterson Hungry I & Patterson Hungry II)
3. Transit to Shepard I
4. Stage 3/7 (Shepard I & Shepard II)
5. Transit to Randall I
6. Stage 4/8 (Randall I & Randall II)
7. Transit to Wilson I
8. Stage 5/9 (Wilson I & Wilson II)
9. Transit to Mill I
10. Stage 10/14 (Mill I & Mill II)
11. Transit to Asaph Long I
12. Stage 11/15 (Asaph Long I & Asaph Long II)
13. Transit To WM Out I
14. Stage 12/16 (WM Out I & WM Out II)
15. Transit to Rattler I
16. Stage 13/17 (Rattler I & Rattler II)
17. Transit to Fairgrounds

While Net Control will not be officially operating, we will be monitoring 147.06 (127.3) repeater frequency.
