The Stewards, having received a report from the FIA Eligibility Delegate (document No 6.1), summoned and heard the drivers and the Competitor (Summons No 1), have considered the following matter, determine the following:

Driver and car No: Car nr. 1 - Lombardo Angelo/Consiglio Roberto

Competitor: Lombardo Angelo

Time (fact): 11:30

Session: Pre-event scrutineering

Fact: Lateness at the pre-event scrutineering

Offence: Breach of article Article 11.1 of the Event Supplementary Regulations.

Decision: Fine of 390.00 Euros

In accordance with Article 12.8 of the FIA International Sporting Code, the payment of fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension during the period a fine remains unpaid.

Reason: The Stewards having received a report from the FIA Eligibility Delegate stating that Car nr. 1 was presented at the pre-event scrutineering at 11:30 hrs, the Stewards summoned and heard from the drivers and the Competitor.

The Competitor explained that they gave all of the event documentation to their Team before the rally to take it to the event. They said they left the Team to take the Car nr. 1 to pre-event scrutineering at the relevant time. They advised that they did not check Bulletin No.1 for their pre-event scrutineering time, and they also confirmed there were no issues with the car which delayed the arrival to pre-event scrutineering.

According to article 11.1 of the Event Supplementary Regulations any crew taking part in the rally (or their representative) must arrive at the Scrutineering and present the car in accordance with the timetable to be issued in a Bulletin. According to Bulletin nr. 1 approved by the FIA for publication on 19/09/2025 and published on the event Digital Notice Board on the same day, Car nr. 1 was scheduled to attend pre-event scrutineering between 09:01 and 09:20 hrs.

Having considered the matter extensively, the Stewards determined that Car nr. 1 was presented to the pre-event scrutineering with lateness from scheduled time and was hence in breach of the above mentioned regulations and applied the penalty provide for by Article 11.1 of the Event Supplementary Regulations, i.e. any lateness in entering the pre-rally Scrutineering area will be sanctioned with a fine of €30 for each 10 minutes delayed.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits (both documents can be found at <https://www.fia.com>).
