Sportska komisija / The Stewards,

je razmortila sljedeće pitanje / have considered the following question:

Činjenice/Facts: Vozač SB 80 nije usporio kretanje uslijed isticanja crvene zastave.
The Driver of SN 80 he did not slow down due to display of the red flag.

Prekršaj/Offence: Kršenje članka 53.5.3. 2026 FIA RRSR-a
Breach of Article 53.5.3. 2026 FIA RRSR

Odluka/Decision: Opomena posadi SB 80 *Gianfranco Belletti / Walter Ussai* sukladno čl.12.4.1.a Dodatka J FIA ISC-a za 2026
Warning to Competitor SN 80 *Gianfranco Belletti / Walter Ussai* in accordance with Art. 12.4.1.a of the 2026 FIA International Sporting Code

Razlog/Reason: Kako je propisano čl. 53.5.3. 2026 FIA RRSR-a ukoliko je istaknuta crvena zastava i/ili elektronička crvena zastava, što god se dogodi prvo, vozač mora odmah smanjiti brzinu, održavati ovu smanjenu brzinu do kraja posebne etape i slijediti upute bilo kojih redara ili vozača interventnih vozila. Nepoštivanje ovog pravila rezultirat će kaznom prema nahodjenju Sportske komisije.
Sportska komisija je odlučila u skladu s člankom 12.4.1.a 2026 FIA International Sporting Code donijeti odluku.

As stipulated in Art. 53.5.3. 2026 FIA RRSR on passing a displayed Red Flag and / or receiving electronic Red Flag, whichever happens first, the driver must immediately reduce speed, maintain this reduced speed until the end of the special stage, and follow the instructions of any marshals or intervention car drivers. Failure to comply with this rule will entail a penalty at the discretion of the Stewards.

The Stewards decided to make a decision in accordance with Article 12.4.1.a of the 2026 FIA International Sporting Code
