The Stewards, having received a report from the Clerk of the Course, have summoned and heard the drivers and the Competitor (Summons nr. 6), as well as the relevant Marshal (by telephone), have considered the following matter, determine the following:

Driver and car No: Car nr. 4 - Angelo Lombardo – Roberto Consiglio

Competitor: Angelo Lombardo

Fact: Alleged misconduct of Crew nr. 4 at TC8

Offence: Alleged breach of Article 12.2.1.I of the 2026 FIA International Sporting Code

Decision: No further action

Reason: The Stewards have received a report from the Clerk of the Course with attached a report from a marshal regarding the possible misconduct of Crew nr. 4 at TC8. The Stewards began an investigation and summoned and heard from the drivers and the Competitor, as well as the Marshal at post TC8 (by telephone, the latter could not have arrived in time for the hearing).

The Marshal explained that Crew nr. 4 expressed their disagreement on the time entered on their time card at TC8, a discussion arised and he had the impression to be insulted.

Crew nr. 4 recognised that they expressed their disagreement on the time entered on their time card at TC8 and that a discussion arised with the Marshal. Crew nr. 4 strongly denied that they were insulting the Marshal. Moreover they apologised that he felt insulted. The Marshal accepted the apologies.

Having taken good note of the explanations of all interested parties, the Stewards note that while it is possible to identify elements of convergence between the Marshal's explanations and those of Crew nr. 4 – in particular the facts that Crew nr. 4 was disagreeing on the time entered on their time card at TC8 and exposed their disagreement to the Marshal disputing the time recorded, following which a discussion arised – so that these elements could therefore be considered as established, the investigation conducted by the Stewards does not allow the latter to be comfortably satisfied that Crew nr. 4 actually engaged in misconduct towards the Marshal to the point of constituting a breach of Article 12.2.1.I of the 2026 FIA International Sporting Code. Consequently, the Stewards determined that there is no clear evidence about possible misconduct of Crew nr. 4 at TC8 and decided to take no further action in this instance.

Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 5 of the FIA Judicial and Disciplinary Rules, within the applicable time limits (both documents can be found at <https://www.fia.com>).
