The Stewards, having received a report from the police and forwarded by the Chief Scrutineer, summoned and heard the drivers and have considered the following matter, determine the following:

**Fact:** Car no 69, at approximately 09h42. on 16/03/2024 at road no GI-542, km 7,9, was reckless driving on the road.

**Offence:** Breach of Art. 12.2.1.c of the FIA International Sporting Code  
Breach of Art. 12.2.1.f of the FIA International Sporting Code

**Decision:** A fine of 200 € to the driver,

In accordance with Article 12.8 FIA International Sporting Code, the payment of the fines must be done online, within 48 hours of their notification, at the following address: <https://fiafines.fia.com>. Any delay in making payment may entail Suspension of both driver during the period a fine remains unpaid.

**Reason:** The competitor was informed accordingly by the Stewards and was given the possibility, if he wished, to bring forward any representations. The crew acknowledges the fact.

With the intention that the administrative traffic sanctions fulfil their educational and corrective value of the observed behaviours, and that they are not reproduced throughout the competition, the responsible of the Police reported this offence to the Clerk of the Course as required by Art. 34.3.2 of the EHRC Sporting Regulations

The Steward concluded that the driver, in proceeding as described above did not take the necessary care on public road. The FIA is dedicated to improving the safety of everyday road users throughout the world. The behaviour of the driver is in contradiction of one of the major objectives of FIA and thus a breach of ISC Art. 12.1.1.c. According ISC Art. 12.1.1.f any deeds that have caused moral injury to the FIA may be penalised by the Steward.

According to the Code all Participants in International Competitions must not to pursue any objective that diverges from those of the FIA. The conduct of the driver is prejudicial to the interests of the Rallye Costa Brava and to the interests of motor sport generally.

The decision is based on the FIA International Sporting Code Art. 11.9.1, art.11.9.2.a, Art. 11.9.3.a, Art. 11.9.3.f, and Art 12.4.1.c.
